On October 23, 2020 Kulczyk Investments S.A. ("**KI**") and WFE Investments Corp. ("**WFE**") entered into a share purchase agreement pursuant to which KI sold and WFE purchased 6,755,209 Common Shares.

Kulczyk Investments S.A., a corporation existing under the laws of Luxembourg. KI'S principal business is investment and portfolio management and its head office address is 35, Avenue Monterey, L-2163 Luxembourg, Grand Duchy of Luxembourg.

On October 23, 2020, KI disposed of 6,755,209 Common Shares representing 28.22% of the outstanding Common Shares.¹
