The Acquiror previously held 10,544,959 Common Shares and options to purchase up to 5,603,000 Common Shares at a price of \$0.005 per share (the "**Options**"), directly and indirectly through WFE Investments Corp., a company controlled by him. Following the Transaction, the Acquiror directly and indirectly has beneficial ownership or exercises control or direction over 12,747,959 Common Shares, representing approximately 53.3% of the outstanding shares of the Corporation and up to 16,147,959 Common Shares assuming the exercise of the remaining Options in full, representing 67.5% on the outstanding shares of the Corporation.

The Acquiror purchased 2,203,000 Common Shares of the Issuer.
