

## Marret High Yield Strategies Fund Announces Filing of Short Form Prospectus

TORONTO, ONTARIO--(August 30, 2011) – Marret Asset Management Inc. is pleased to announce that Marret High Yield Strategies Fund (TSX: MHY.UN) (the “Fund”) has filed a short form prospectus in each of the provinces of Canada and the territory of Yukon with respect to an additional offering of a maximum of 18,500,000 units of the Fund at a price of \$11.05 per unit. Closing of the offering is expected to occur on September 7, 2011.

The Fund has also granted the agents an over-allotment option, exercisable in whole or in part at any time up to 30 days after closing, to purchase an additional 2,775,000 units at a price of \$11.05 per unit.

The Fund seeks to achieve the following investment objectives: (i) to maximize total returns for unitholders consisting of both tax-advantaged distributions and capital appreciation, while reducing risk; and (ii) to provide unitholders with attractive monthly tax-advantaged cash distributions.
