Body and Mind Inc. Updates Progress in Filing Financial Statements

LAS VEGAS, NV and VANCOUVER, B.C., CANADA (January 5, 2023) – Body and Mind Inc. (CSE: BAMM, US OTCQB: BMMJ) (the "Company" or "BaM") is providing an update regarding its delayed annual financial statements for the year ended July 31, 2022, including the related management discussion and analysis, and CEO and CFO certifications (collectively, the "2022 Annual Financial Filings").

Although the audit process is substantially complete, the additional final procedures include (i) final approval from an external valuation consultant for the auditor, (ii) updating a tax provision and (iii) final internal QC (quality control) sign-off from the auditor.

The Company and auditors are working closely to complete the 2022 Annual Financial Filings and will continue to provide updates in accordance with National Policy 12-203 (Management Cease Trade Orders).

BaM is an operations-focused cannabis company with active retail operations in Ohio, Arkansas, Michigan and California, pending retail operations in Illinois and New Jersey, and craft cultivation and/or processing operations in Nevada, Ohio and Arkansas. We are primarily guided by the metric of return on investment. Currently, we believe the most significant return on investment projects in front of us are successful retail cannabis store launches in Illinois and New Jersey, which augment our existing retail footprint.
