**SGX Resources Inc. Announces Amendment to Warrant Terms**

Dale Ginn, CEO of SGX Resources Inc. ("SGX") (SXR: TSX-V), announced today that SGX has received approval from the TSX Venture Exchange to extend the maturity date of its outstanding common share purchase warrants (the "Warrants") issued on April 27, 2011 pursuant to a private placement offering. The TSX Venture Exchange has approved the extension of the maturity date of the Warrants from April 27, 2013 to April 27, 2014. None of the other terms of the Warrants have changed. There are currently 1,500,000 Warrants issued and outstanding. Each Warrant now entitles the holder to purchase one common share of SGX at a price of \$0.35 per share until April 27, 2014.
