**ME RESOURCES CORP. ANNOUNCES AN AGREEMENT WITH PAKISTANI COMPANY
HOLDING AN EXPLORATION LICENCE IN PROLIFIC CHAGI MINERAL BELT IN PAKISTAN**

March 6, 2012, VANCOUVER, BRITISH COLUMBIA – ME Resource Corp. ("**Company**") (CNSX: MEC) announces that the Company has entered into an Agreement (the "**Agreement**") with a Pakistani Company ("**PakCo**") holding an Exploration License in Southwest Pakistan's Chagi Copper-Gold Mineral Belt. The Agreement calls for a significant investment in the Province of Baluchistan to further the exploration and development of the property, bringing with it new technologies and creating jobs for the local industry.

Mr. Mukarram Zehri, a director of the Company, holds a controlling interest in PakCo. As part of the Agreement, Mr. Zehri will seek nomination as President of the Company at the next annual general meeting. Asked for comment on the Agreement, Mr. Zehri stated, "Bringing investment into Baluchistan, creating new jobs, and keeping this in local control was my biggest motivation. Hopefully, the success of this project will pave the way for new investment into the province and for the people of Baluchistan".

The Agreement calls for the issuance of 3,000,000 common shares ("**Consideration Shares**") of the Company, from treasury, to the Vendor. In addition, the Company will make a CDN \$2,000,000 equity investment to finance a work program and related expenditures. The issuance of the Consideration Shares will establish Mr. Zehri as a major shareholder of the Company, which will have earned a 99% interest in PakCo, the entity which holds the mineral license.

Mr. Mukarram Zehri is considered a "Related Party" pursuant to Canadian National Stock Exchange (the "Exchange") policies.

The Agreement was unanimously approved by the Board of Directors of the Company, other than Mr. Zehri, who declared his interest in PakCo and abstained from voting with respect to the transaction related thereto.

The Company will now seek to obtain final exchange and regulatory approval.

ME Resource Corp. is a Canadian mineral exploration company focused on the acquisition, exploration and development of properties that have good potential for world class gold and base metal deposits. The Company's objective is to explore and develop the current mineral claims and pursue additional acquisitions. The Corporation intends to acquire a portfolio of properties through project acquisitions, joint ventures and alliances.
