**THOMAS ENGLISH ACQUIRES SECURITIES OF
ECHELON PETROLEUM CORP.**

VANCOUVER, Canada (April 15, 2016) – Thomas English, announces that on April 14, 2016, he acquired ownership of 2,000,000 common shares (“**Shares**”) of Echelon Petroleum Corp. (“**Echelon**”) at \$0.06 per Share in a private placement transaction. The Shares of Echelon are listed on the TSX Venture Exchange under the trading symbol ECH.H.

As a result of the foregoing, Thomas English owns a total of 2,000,000 Shares of Echelon, representing 17.34% of Echelon’s issued and outstanding shares.

The securities acquired will be held for investment purposes. Thomas English may, depending on market conditions and a number of other factors, increase or decrease his beneficial ownership of Echelon’s securities, whether in the open market, by privately negotiated agreements or other available investment or business opportunities.
