On June 16, 2021, 2176423 Ontario, a corporation beneficially owned by Eric Sprott, acquired ownership of 6,666,667 Units of the Corporation at a price of \$0.15 per Unit. Each Warrant comprising part of a Unit entitles the holder thereof to acquire one Share at a price of \$0.20 per Share until two years after the issuance of the Warrant. 2176423 Ontario is beneficially owned by Mr. Sprott. Concurrently, Mr. Sprott acquired ownership of 5,555,555 FT Units of the Corporation at a price of \$0.18 per FT Unit. Each Warrant comprising part of a FT Unit entitles the holder thereof to acquire one Share at a price of \$0.24 per Share until two years after the issuance of the Warrant. The Units and FT Units were purchased from the Corporation on a private placement basis.

The 6,666,667 Units and 5,555,555 FT Units represent approximately 12.7% of the issued and outstanding Shares on a non-diluted basis, and approximately 22.6% on a partially diluted basis. See item 3.4.

Mr. Sprott acquired beneficial ownership of the Units and FT Units. See item 2.2.

After giving effect to the acquisition, Mr. Sprott beneficially owns and controls 12,222,222 Shares and 12,222,222 Warrants, representing approximately 12.7% of the issued and outstanding Shares on a non-diluted basis, and approximately 22.6% on a partially diluted basis assuming exercise of the Warrants.

Not applicable. The FT Units and Units were acquired for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
