Common shares of AXS Blockchain Solutions Inc. (the “**Issuer**”), head office located at Suite 1140, 1185 West Georgia Street, Vancouver, British Columbia.

This report is filed in respect of the acquisition of common shares of the Issuer in connection with the sale of certain assets to the Issuer (the “**Transaction**”).

The acquiror is Blockcorp Sociedad Anonima (“**Blockcorp**”), of Residencial Vistana, Real #11, Santa Ana, Costa Rica.

On March 27, 2018, Blockcorp acquired 82,500,000 common shares of the Issuer pursuant to the Transaction, which involved the sale of certain assets of Blockcorp to the Issuer.

Blockcorp acquired ownership and control of 82,500,000 common shares in the capital of the Issuer. The acquisition of the common shares represents approximately 49.5% of the Issuer’s current issued and outstanding common shares.

Blockcorp acquired ownership and control of the securities that are the subject of this report.

Following completion of the Transaction, Blockcorp has ownership and control of 82,500,000 common shares of the Issuer, representing approximately 49.5% of the issued and outstanding common shares of the Issuer.

Blockcorp has ownership and control over 82,500,000 common shares of the Issuer, representing approximately 49.5% of the issued and outstanding common shares of the Issuer.

The common shares were acquired in consideration for certain assets of Blockcorp which were transferred to the Issuer. The shares were issued at a deemed price of \$0.35 per share for aggregate consideration of \$28,875,000.
