Common shares of AXS Blockchain Solutions Inc. (the “**Issuer**”), head office located at Suite 1140, 1185 West Georgia Street, Vancouver, British Columbia.

This report is filed in respect of the disposition of common shares of the Issuer. The disposition was carried out privately, and did not take place on any market.

The acquiror is Blockcorp Sociedad Anonima (“**Blockcorp**”), of Residencial Vistana, Real #11, Santa Ana, Costa Rica.

On August 1, 2018, Blockcorp disposed of 8,250,000 common shares of the Issuer in private transactions, in connection with the reorganization of its assets.

Blockcorp disposed of 8,250,000 common shares of the Issuer. The disposition of the common shares represents approximately 4.9% of the Issuer’s current issued and outstanding common shares.

The requirement to file this report was triggered by the disposition of common shares of the Issuer by Blockcorp.

Immediately prior to the disposition, Blockcorp held 82,500,000 common shares of the Issuer, representing approximately 49.5% of the issued and outstanding common shares of the Issuer. Following completion of the disposition, Blockcorp has ownership and control of 74,250,000 common shares of the Issuer, representing approximately 44.5% of the issued and outstanding common shares of the Issuer.

Following completion of the disposition, Blockcorp has ownership and control of 74,250,000 common shares of the Issuer, representing approximately 44.5% of the issued and outstanding common shares of the Issuer.
