Common shares of LiteLink Technologies Inc. (the “**Issuer**”), head office located at Suite 260, 3480 Gilmore Way, Burnaby, British Columbia.

This report is filed in respect of the disposition of common shares of the Issuer. The disposition was carried out privately, and did not take place on any market.

The acquiror is Blockcorp Sociedad Anonima (“**Blockcorp**”), of Residencial Vistana, Real #11, Santa Ana, Costa Rica.

On May 31, 2019, Blockcorp disposed of 11,613,750 common shares of the Issuer in private transactions, in connection with an ongoing reorganization of its assets.

Blockcorp disposed of 11,613,750 common shares of the Issuer. The disposition of the common shares represents approximately 6.9% of the Issuer’s current issued and outstanding common shares.

The requirement to file this report was triggered by the disposition of common shares of the Issuer by Blockcorp.

Immediately prior to the disposition, Blockcorp held 74,250,000 common shares of the Issuer, representing approximately 44.1% of the issued and outstanding common shares of the Issuer. Following completion of the disposition, Blockcorp has ownership and control of 62,636,250 common shares of the Issuer, representing approximately 37.2% of the issued and outstanding common shares of the Issuer.
