On April 21, 2022, Mr. Irwin acquired 5,000,000 units in the capital of the Company pursuant to a third-party transaction (the “**Acquisition**”). Each Unit is comprised of one common share (each, a “**Common Share**”) in the capital of the Company and one-half of one whole Common Share purchase warrant (each whole warrant, a “**Warrant**”). Each Warrant will entitle the holder to acquire an additional Common Share at an exercise price of no less than \$0.50 for a period of two years from the date of issuance.

Prior to the completion of the Acquisition, Mr. Irwin held, directly or indirectly, 16,666 Common Shares and 8,333 Warrants. Upon completion of the Debt Settlement, Mr. Irwin will beneficially own or control 5,016,666 Common Shares of the Company and 2,508,333 Warrants, representing approximately 32.32% of the Company's issued and outstanding Common Shares on a non-diluted basis and approximately 41.65% of the Company's issued and outstanding Common Shares on a partially basis.

In the future, Mr. Irwin, will evaluate his investment in the Company from time to time and may, based on such evaluation and the market conditions and other circumstances, increase or decrease his security holdings through market transactions, private agreements, or otherwise.
