Re: Amendment to Amalgamation Agreement dated June 19, 2013, as amended June 28, 2013, July 31, 2013 and October 31, 2013

We are writing to document the agreement of Redlion Resources Corp. ("Redlion"), Bravura Ventures Corp. ("Bravura") and O972774 B.C. Ltd ("Newco") to amend the Amalgamation Agreement among them dated June 19, 2013, as amended June 28, 2013, July 31, 2013 and October 31, 2013 (the "Amalgamation Agreement"). Pursuant to the Amalgamation Agreement, Bravura and Redlion agreed to complete a business combination by way of an amalgamation of Redlion and Newco, a wholly-owned subsidiary of Bravura, under the provisions of the *Business Corporations Act* (British Columbia).

The parties have agreed, effective November 30, 2013, to amend the Amalgamation Agreement as follows:

(1) by deleting section 1.1(x) in its entirety and replacing it as follows:

(x) *"Completion Deadline" means the latest date by which the transactions contemplated by this Agreement are to be completed, which date shall be March 1, 2014 or such later date as the Parties may mutually agree.*

(2) by deleting the first paragraph of section 4.3(a) in its entirety and replacing it as follows:

(a) *Completion of Amalgamation. Each of the Parties agrees that it shall complete the Amalgamation on the date mutually agreed to by the Parties that is following the filing of the Filing Statement on SEDAR and prior to the Completion Deadline. [...]*

Except as amended hereby, the Amalgamation Agreement continues in full force and effect and the Amalgamation Agreement and this letter agreement will be read and construed together as one agreement. The parties ratify and affirm the Amalgamation Agreement, as amended hereby, and agree that the Amalgamation Agreement, as modified hereby, contains the entire understanding of the parties hereto with respect to the subject matter hereof. The Amalgamation Agreement, as amended hereby, supersedes all prior agreements and understandings between the parties with respect to such subject matter. Each party, upon the request of any other party hereto shall do, execute, acknowledge and deliver, or cause to be done, executed, acknowledged or delivered, all such further acts, deeds, documents, and assurances as may be reasonably necessary or desirable to give effect to the transactions contemplated in the Amalgamation Agreement, as amended hereby.
