QUANTUM BATTERY METALS CLOSES PRIVATE PLACEMENT FOR \$500,000

Vancouver, British Columbia – Quantum Battery Metals Corp. (CSE: QBAT; OTC: BRVVF; FRA: 23B0) (“Quantum” or the “Company”) announces that it has closed its previously announced non-brokered private placement (the “Private Placement”) comprising of 1,470,588 Units (“Units”) at a price of \$0.34 Unit for gross proceeds of \$500,000.00.

Each Unit is comprised of one common share and one common share purchase warrant of the Company. Each warrant will be exercisable into a common share of the Company for a period of 24 months at an exercise price of \$0.42 for 24 months from issuance. The proceeds of the private placement will be used for the mineral properties of the Company and general working capital.
