Fia is a director and the CEO of the Issuer.

On April 24, 2017, the Issuer issued 1,953,602 Icon Shares to Fia at a deemed price of \$0.05/share in consideration for the settlement of \$97,680.09 debt owed to Fia.

Prior to the shares for debt issuance, Fia owned or controlled 1,824,210 Icon Shares representing approximately 11.9% of the outstanding Icon Shares.

Upon completion of the shares for debt transaction, Fia now has ownership or control over an aggregate of 3,777,812 Icon Shares, representing approximately 18.4% of the outstanding Icon Shares, on a non-diluted basis.

On a partially diluted basis (assuming the exercise of all 541,583 stock options held by Fia), Fia would have ownership and control over approximately 20.5% of the then issued Icon Shares.
