On July 19, 2017, the Issuer issued 2,635,967 Icon Shares to Gamble at a deemed price of \$0.05/share in consideration for the settlement of \$131,798.36 debt owed to Gamble.

Prior to the shares for debt issuance, Gamble owned or controlled 332,000 Icon Shares representing approximately 1.6% of the outstanding Icon Shares.

Upon completion of the shares for debt transaction, Gamble now has ownership or control over an aggregate of 3,167,967 Icon Shares, representing approximately 13.6% of the outstanding Icon Shares, on a non-diluted basis.

On a partially diluted basis (assuming the exercise of all 449,908 stock options held by Gamble), Gamble would have ownership and control over approximately 15.2% of the then issued Icon Shares.
