Fia is a director and the CEO of the Issuer.

On December 17, 2018, Fia exercised 312,500 share purchase warrants at a price of \$0.15/share.

Prior to this warrant exercise, Fia owned or controlled 4,300,812 Icon Shares representing approximately 11.9% of the outstanding Icon Shares. In an Early Warning Report dated August 4, 2017, Fia disclosed his share ownership interest represented approximately 16.1% of the then issued and outstanding Icon Shares. The decrease in Fia’s ownership interest since that time is a result of the Issuer’s subsequent issuance of

securities to persons other than Fia upon completion of private placements and other warrant exercises.

Upon completion of this current warrant exercise, Fia now has ownership or control over an aggregate of 4,613,312 Icon Shares, representing approximately 13.9% of the outstanding Icon Shares, on a non-diluted basis.

On a partially diluted basis (assuming the exercise of all 1,341,583 stock options held by Fia), Fia would have ownership and control over approximately 17.3% of the then issued Icon Shares.
