On December 24, 2020, Fia acquired 2,000,000 units (the "**Units**") of the Company at a price of \$0.05/Unit in the Company's private placement financing. Each Unit is comprised of one City View Share and ½ share purchase warrant. Each whole share purchase warrant is exercisable for one City View Share at a price of \$0.10 for two years, subject to acceleration provisions.

Prior to the issuance of these Units, Fia owned or controlled 22,489,910 City View Shares representing approximately 9.3% of the outstanding City View Shares. Upon issuance of the 2,000,000 Units, Fia now owns or controls 24,489,910 City View Shares, representing approximately 10% of the outstanding City View Shares, on a non-diluted basis.

On a partially diluted basis (assuming the exercise of all 11,340,000 stock options and 2,000,000 warrants held by Fia), Fia would have ownership and control over approximately 14.6% of the then issued City View Shares.
