**INTERIM MANAGEMENT'S DISCUSSION AND ANALYSIS –
QUARTERLY HIGHLIGHTS**

FOR THREE AND SIX MONTHS ENDED JUNE 30, 2024

Introduction

The following interim Management’s Discussion & Analysis (“MD&A”) of City View Green Holdings Inc. (“City View” or the “Company”) for the three and six months ended June 30, 2024 summarize the activities of City View for the three and six months ended June 30, 2024 and should be read in conjunction with the audited financial statements for the year ended December 31, 2023 and 2022, together with the notes thereto, and unaudited condensed interim financial statements for the three and six months ended June 30, 2024, together with the notes thereto.

Results are reported in Canadian dollars, unless otherwise noted. The Company’s unaudited condensed interim financial statements and the financial information contained in this MD&A are prepared in accordance with International Financial Reporting Standards (“IFRS”) as issued by the International Accounting Standards Board and interpretations of the IFRS Interpretations Committee. The unaudited condensed interim financial statements have been prepared in accordance with International Standard 34, Interim Financial Reporting. Accordingly, information contained herein is presented as of August 22, 2024, unless otherwise indicated.

For the purposes of preparing this MD&A, management, in conjunction with the Board of Directors, considers the materiality of information. Information is considered material if: (i) such information results in, or would reasonably be expected to result in, a significant change in the market price or value of City View’s common shares; or (ii) there is a substantial likelihood that a reasonable investor would consider it important in making an investment decision; or (iii) it would significantly alter the total mix of information available to investors. Management, in conjunction with the Board of Directors, evaluates materiality with reference to all relevant circumstances, including potential market sensitivity.

Description of Business

The Company was incorporated pursuant to the Canada Business Corporations Act on February 5, 2008. The Company continued into British Columbia from the jurisdiction of Canada, under the BCBCA, on February 18, 2011. On February 27, 2019, the Company completed a reverse take-over business combination with 2590672 Ontario Inc. wherein the Company acquired 100% of the issued and outstanding common shares of 2590672 Ontario Inc. and began trading on the Canadian Securities Exchange (“Exchange”) under the symbol “CVGR”. The Company’s registered office is located at 345 Danforth Avenue, Toronto, Ontario, M4K 1N7.

On April 30, 2021, the Company received the cannabis processing license from Health Canada. The processing license allows the Company to produce cannabis edibles and related products and to conduct development activities, including the formulation of proprietary cannabis infused edibles.

On April 21, 2022, the Company also received its cannabis research licence under Health Canada. This licence permits the Company to conduct controlled human sensory (taste) trials of cannabis infused products. Activities granted include, 1) to possess cannabis for the purpose of research, and 2) to produce cannabis for the purpose of research. As an essential part of new product development, taste tests will lead the Company to bring to market high quality edibles that are reflective of market trends and consumer preference.

City View is a consumer packaged goods company focused on the development of cannabis-infused edibles. With the receipt of its Cannabis Act processing licence on April 30, 2021 through its wholly owned subsidiary, City View will incorporate high-capacity cannabis-infused food production. In addition, City View owns a 27.5% stake in Budd Hutt Inc. ("Budd Hutt"), a retail-focused cannabis company with access to cannabis cultivation and production licences in Alberta and other retail opportunities across Canada. In April 2024, the Company announced it is exiting the retail cannabis space through its ownership in Budd Hutt. For more information visit: www.cityviewgreen.ca.

Operational Highlights

On March 4, 2024, the Company announced that it intends to raise gross proceeds of up to \$1,000,000 through a non-brokered private placement of up to 100,000,000 units of the Company at a price of \$0.01 per unit. Each unit will consist of one common share in the capital of the Company and one-half common share purchase warrant. Each whole warrant will entitle the holder thereof to acquire one common share of the Company at a price of \$0.05 per share for a period of 3 years following the date of issuance; except that, from and after the date that is one year after the closing date, if the average closing price of the Company's common shares on the CSE is equal to or exceeds \$0.055 during any 10 trading day period, then the Company may anytime thereafter accelerate the expiry date of the warrants to the date that is 30 days following the date on which the Company issues notice to all warrant holders of the new expiry date.

On April 17, 2024, the Company announced it is exiting the retail cannabis space through its ownership in Budd Hutt. Also, Gunter Bell resigned as a director of the Company.

On June 20, 2024, the Company closed the first tranche of a non-brokered private placement, pursuant to which it issued 9,500,000 units at \$0.01 per unit for aggregate gross proceeds of \$95,000. Each unit consisted of one common share of the Company and one half share purchase warrant. Each whole warrant entitles the holder to purchase one common share of the Company at a price of \$0.05 per share for a period of 3 years from the closing date, except that, from and after the date that is one year after the closing date, if the average closing price of the Company's common shares on the CSE is equal to or exceeds \$0.055 during any 10 trading day period, then the Company may anytime thereafter accelerate the expiry date of the warrants to the date that is 30 days following the date on which the Company issues notice to all the warrant holders of the new expiry date.

Discussion of Operations

Three Months Ended June 30, 2024 Compared to Three Months Ended June 30, 2023

The Company's net loss totaled \$244,328 for the three months ended June 30, 2024 with basic and diluted loss per share of \$0.00 (2023 – net loss of \$248,868, with basic and diluted loss per share of \$0.00). The change in net loss was mainly due to the following:

- The Company had \$nil revenue for the three months ended June 30, 2024 (2023 - \$2,251).
- Consulting increased to \$127,158 for the three months ended June 30, 2024 (2023 - \$56,250) as more external consultants were used during the current period.
- Depreciation decreased to \$nil for the three months ended June 30, 2024 (2023 - \$74,830) as the Company impaired its equipment in 2023.

Six Months Ended June 30, 2024 Compared to Six Months Ended June 30, 2023

The Company's net loss totaled \$251,967 for the six months ended June 30, 2024 with basic and diluted loss per share of \$0.00 (2023 – net loss of \$524,651, with basic and diluted loss per share of \$0.00). The change in net loss was mainly due to the following:

- The Company had \$nil revenue for the six months ended June 30, 2024 (2023 - \$8,582).
- Consulting increased to \$209,112 for the six months ended June 30, 2024 (2023 - \$150,822) as more external consultants were used during the current period.
- Depreciation decreased to \$nil for the six months ended June 30, 2024 (2023 - \$149,660) as the Company impaired its equipment in 2023.
- Gain on sale of property and equipment increased to \$172,701 for the six months ended June 30, 2024 (2023 - \$nil) as the Company sold its equipment in 2024.

Liquidity and Financial Position

The activities of the Company have been financed through the completion of equity transactions such as equity offerings and the exercise of stock options and warrants. There is no assurance that equity capital will be available to the Company in the amounts or at the times desired or on terms that are acceptable to the Company, if at all.

Cash Flows

At June 30, 2024, the Company had cash balance of \$30,824 (December 31, 2023 - \$343). The increase in was as a result of cash inflow in financing activities of \$57,710, partially offset by cash outflow from operating activities of \$27,229.

Operating activities were affected by adjustments of accrued interest of \$49,399 and net change in non-cash working capital balances of \$175,339 due to changes in amounts receivable and accounts payable and accrued liabilities.

Financing activities included proceeds from issuance of shares of \$95,000, partially offset by advances to related parties of \$27,290.

Liquidity and Financial Position

As at June 30, 2024, the Company had a working capital deficiency of \$3,886,094 (December 31, 2023 – working capital deficiency of \$3,729,127). The Company also incurred a net loss of \$251,967 during the six months ended June 30, 2024 and has yet to achieve profitable operations thereby accumulating a deficit of \$44,355,370 (December 31, 2023 - \$44,103,403). These continuing losses cast significant doubt about the Company’s ability to continue as a going concern. Accordingly, the Company will need to raise additional capital through equity issuance and other available means in order to continue funding its operations. The outcome of these matters cannot be predicted at this time.

Related Party Transactions

Related parties include key management being the Company's executive officers, the Board of Directors, close family members and enterprises that are controlled by these individuals as well as certain persons performing similar functions. The following related party transactions were conducted in the normal course of operations and were made on an arm's length basis:

As at June 30, 2024, \$853,361 (December 31, 2023 - \$745,058) included in accounts payable and accrued liabilities was payable to key management personnel.

As at June 30, 2024, the directors of the Company advanced a total of \$67,399 (December 31, 2023 - \$104,689). The advance is non-interest bearing and repayable on demand.

Off-Balance-Sheet Arrangements

As of the date of this MD&A, the Company does not have any off-balance-sheet arrangements that have, or are reasonably likely to have, a current or future effect on the results of operations or financial condition of the Company, including, and without limitation, such considerations as liquidity and capital resources.

Proposed Transactions

There are no proposed transactions of a material nature being considered by the Company. The Company continues to evaluate properties and corporate entities that it may acquire in the future.

Disclosure of Internal Controls

Management has established processes to provide them sufficient knowledge to support representations that they have exercised reasonable diligence that (i) the financial statements do not contain any untrue statement of material fact or omit to state a material fact required to be stated or that is necessary to make a statement not misleading in light of the circumstances under which it is made, as of the date of and for the periods presented by the financial statements; and (ii) the financial statements fairly present in all material respects the financial condition, results of operations and cash flows of the Company, as of the date of and for the periods presented.

Capital Risk Management

The Company manages its capital with the following objectives:

- to ensure sufficient financial flexibility to achieve the ongoing business objectives including funding of future growth opportunities, and pursuit of accretive acquisitions; and
- to maximize shareholder return through enhancing the share value.

The Company monitors its capital structure and makes adjustments according to market conditions in an effort to meet its objectives given the current outlook of the business and financial markets in general. The Company may manage its capital structure by issuing new shares, repurchasing outstanding shares, or adjusting spending. The capital structure is reviewed by management and the Board of Directors on an ongoing basis.

The Company considers its capital structure to consist of share capital, contributed surplus, and deficit, which at June 30, 2024 totaled a deficiency of \$3,886,094 (December 31, 2023 – deficiency of \$3,729,127). The Company reviews its working capital and forecasts its future cash flows based on operating expenditures, and other investing and financing activities. Selected information is provided to the Board of Directors of the Company. The Company is not subject to any capital requirements imposed by a lending institution.
