This notice is provided pursuant to the requirements of Section 4.9 of National Instrument 51-102 – *Continuous Disclosure Obligations*.

Item 1: Names of the Parties to the Transaction

GTO Resources Inc. (the "**Company**"), a company incorporated under the laws of British Columbia.

Firebird Resources Inc. ("Firebird"), a company existing under the laws of British Columbia.

Item 2: Description of the Transaction

Pursuant to an arrangement agreement between Firebird and the Company dated May 12, 2011, the Company acquired all of Firebird's interest in and to the Roberts Creelman Property, an early stage exploration project consisting of three contiguous unpatented, unleased mining claims comprised of 34 claim units covering approximately 544 hectares in the Roberts and Creelman Townships, located approximately fifty (50) kilometers north of Sudbury, Ontario (the "**RCU Property**"), and the Hyman Porter Property, comprised of 70 claims totalling approximately 1120 hectares in the Hyman and Porter Townships, located approximately fifty (50) kilometers west of Sudbury, Ontario, in exchange for common shares (the "**Company Shares**") of the Company (the "**Arrangement**"). Pursuant to the terms of the Arrangement, each Firebird shareholder as at 12:01 a.m. on July 27, 2011, being the effective date, received one new common share in the capital of Firebird and one-half Company Share for each Firebird common share then held, other than as set forth in the Arrangement.

Pursuant to the Arrangement, holders of common share purchase warrants of Firebird ("**Firebird Warrants**") received, in exchange for each Firebird Warrant then held, one new common share purchase warrant of Firebird and one-half of one common share purchase warrant of the Company, all of which (i) have an exercise price equal to the existing exercise price of the Firebird Warrant exchanged, and (ii) have a term equal to the term remaining on the Firebird Warrants exchanged, and the Firebird Warrants were cancelled and terminated and cease to represent any right or claim whatsoever.

Firebird's common shares will continue to be listed on the Exchange under the stock symbol "FIX". The common shares of the Company will commence trading on the Exchange under the stock symbol "GTR" effective the open of the market on July 28, 2011.

Item 3. Effective Date of the Transaction

Item 4. Names of Each Party that Ceased to be a Reporting Issuer Subsequent to the Transaction and of Each Continuing Entity

In connection with the Arrangement, the Company became a reporting issuer in British Columbia and Alberta. Firebird continues to be a reporting issuer in British Columbia and Alberta.

Item 5. Date of the Reporting Issuer's First Financial Year-End Subsequent to the Transaction

The first financial year-end for the Company following the completion of the Arrangement will be April 30, 2012.
