NOTE TO READERS

The following is management's discussion in respect of the results of operations and financial position of Chimata Gold Corp. (the "Company" or "Chimata"), formerly Maxtech Resources Inc., for the three months ended March 31, 2012 and should be read in conjunction with the Company's unaudited condensed interim financial statements for the same period and audited financial statements for the most year ended December 31, 2011. Effective January 1, 2011 the Company adopted International Financial Reporting Standards ("IFRS") as required by the Canadian Institute of Chartered Accountants. In accordance with these requirements the transition date for implementation of IFRS was November 16, 2010, being the Company's incorporation date. Except as otherwise noted, all amounts reported in this MD&A and the accompanying financial statements have been presented in accordance with IFRS. The financial statements of the Company are presented in Canadian dollars. Additional information, including the above mentioned financial statements, which contain extensive disclosure of the history and properties of the Company are available on SEDAR and may be accessed at <u>www.sedar.com</u>.

ABOUT CHIMATA GOLD

The Company was incorporated under the *Business Corporations Act* (British Columbia) (the "Act") on November 16, 2010, as Maxtech Resources Inc.as a wholly owned subsidiary of Maxtech Ventures Inc. ("Maxtech") for the purpose of mineral property acquisition and development. The Company changed its name to Chimata Gold Corp. on February 10, 2011.

On January 15, 2011, the Company entered into an arrangement agreement (the "Arrangement Agreement") with Maxtech, the ex-parent company, to proceed with a corporate restructuring by way of statutory plan of arrangement under the provisions of the Act (the "Arrangement"), wherein Maxtech was to transfer all of its interest in and to the Guercheville mineral properties, located in Abitibi region of Québec, to the Company.

CORPORATE OVERVIEW AND OVERALL PERFORMANCE

Corporate Restructuring

In order to complete the Arrangement several milestones had to be met, including:

- ✓ Obtaining approval of Maxtech's shareholders received on March 17, 2011;
- ✓ Obtaining approval of the Supreme Court of British Columbia received on March 25, 2011; and
- ✓ Obtaining conditional approval of the TSX Venture Exchange (the "TSXV") to list its shares on the TSXV - received on August 17, 2011;

As a result of meeting these milestones, the Arrangement became effective on August 17, 2011 and the Company spun out from Maxtech and became a reporting issuer. The Company's common shares started trading on the TSXV on September 16, 2011, under the symbol "CAT".

Following the completion of the Arrangement, the Company's principal business became the exploration and development of the Guercheville mineral properties. The Company may also acquire additional properties and carry out early stage exploration on such mineral properties and then sell, option or joint venture the mineral properties.

Private Placement in Progress

The Company announced on March 9, 2012 that it planned to conduct a private placement consisting of up to 12,500,000 units at \$0.05 per unit (the "Unit") to raise an aggregate total of \$625,000 (the "Financing"). Each Unit will consist of one common share ("Share") and one common share purchase warrant ("Warrant"), with each Warrant exercisable into one Share in the equity of the company at a price of \$0.10 per Share for a period of two years from the closing of the Financing. The proceeds of the Financing will be used to repay the loan advanced by Maxtech, the company's former parent.

A finder's fee may be payable on this private placement. Shares issued from this Financing will be subject to a four-month hold.

As at the date of this MD&A, the Company has raised an aggregate total of \$200,000 through the sale of 4,000,000 Units.

Exploration and Evaluation Assets Update

During the three months ended March 31, 2012, the Company is evaluating the work programs recommended in the 43-101 report and has not incurred exploration expenditure on Guercheville properties. Continuity of the Guercheville properties is as follows:

Proposed Acquisition of Mineral Properties

During the quarter ended March 31, 2012, the Company has paid \$200,000 refundable deposit for the bidding of various mineral properties in Manitoba, Canada. As at the March 31, 2012, the acquisition is not completed.

Proposed Share Consolidation

On May 10, 2012, shareholders of the Company approved a special resolution authorizing the consolidation of the issued and outstanding common shares of the Company (the "Common Shares") on the basis of one (1) post-consolidation Common Share for up to every three (3) pre-consolidation Common Shares (the "Share Consolidation") that are outstanding, with the actual consolidation ratio to be determined by the Board of Directors of the Company. The actual consolidation is not determined as at the date of this MD&A.

The Company currently has an unlimited number of authorized Common Shares and the Company will continue to have an unlimited number of authorized Common Shares after the completion of the Share Consolidation.

RESULTS OF OPERATION

The Company is an exploration stage company and has not earned revenue since inception.

First Quarter Ended March 31, 2012 ("2012 Q1")

During 2012 Q1, the Company had a loss of \$42,350 (2011 Q1 - \$4,500) which was mainly a result of incurring accretion expense of \$20,794 (2011 Q1 - \$Nil), \$10,060 in consulting fees (2011 Q1 - \$Nil), and \$7,500 occupancy fees (2011Q1 - \$Nil). The Company was not active during 2011 Q1, thus incurred only small amount of professional fees in 2011.

The accretion expense is the interest accrued using the 15% effective interest rate for the promissory note (with principal of \$600,000) due to Maxtech. Consulting fees are fees paid to various consultants, including the Company's Chief Financial Officer ("CFO") for the management services provided.

Management intends to minimize the Company's operating expenses when the Company remains as a exploration stage company.

As at March 31, 2012, the Company's cash balance, prepaid, exploration and evaluation assets, note payable was \$316,301 (December 31, 2011 - \$530,418), \$200,000 (December 31, 2011 - \$Nil), \$359,624 (December 31, 2011 - \$359,624), and \$607,216 (December 31, 2011 - \$586,422) respectively. The decrease in cash is mainly a result of the increase in prepaid of \$200,000 and the payment of operating expenses in 2012 Q1. Increase of note payable was a result of accruing the unpaid interest at the effective interest rate of 15%.

The Company was incorporated on November 16, 2010 and has a short year ended on December 31, 2010. Thus only information of six quarters is available to disclose.

LIQUIDITY AND CAPITAL RESOURCES

The Company is an exploration stage company and has not earned revenue from operating activities since inception. Financing of operations has been achieved by equity and debt financing. As at March 31, 2012, the Company had \$316,301 in cash, and working capital deficit of \$100,460. As discussed in the section "Private Placement in Progress", the Company has raised \$200,000 through a private placement to eliminate the working capital deficit in April 2012.

During the three months ended March 31, 2012, the Company did not have cash inflow/outflow from its financing activities. Cash used in investing activities was \$200,000 which represented a refundable deposit paid for the bidding of various mineral properties in Manitoba, Canada.

The Company has no operations that generate cash inflow and will need to raise additional funds to continue its exploration activities and cover administrative expenses. While management believes the Company has adequate liquidity to meets its current operational needs, management is aware of the

Company's long term financial success is dependent on discovering properties that contain mineral reserves that are economically recoverable. While the Company has a history of financing its operation through debt or equity financing in the past, there are no guarantees that the Company can do so in the future.

The Company is not subject to external capital requirements and does not have capital commitment as of the date of this MD&A.

OFF BALANCE SHEET ARRANGEMENTS

The Company does not have off-balance sheet arrangements.

PROPOSED TRANSACTIONS

Company does not have any proposed transactions to discuss at this time, except the proposed private placement and the purchase of mineral properties discussed in other sections in this MD&A.

CRITICAL ACCOUNTING ESTIMATES

Not applicable, the Company is a venture issuer.

OUTSTANDING SHARE DATA

As of the date of this MD&A, the Company has 37,649,002 shares issued and outstanding and 4,000,000 share purchase warrants that can be convertible to the Company's common share on one-to-one basis. The Company does not have options outstanding as at the date of this MD&A that are convertible to common shares of the Company.

TRANSACTIONS WITH RELATED PARTIES

During the three months ended March 31, 2012, the Company incurred \$2,560 (Three Months Ended March 31, 2011("2011 Q1") - \$Nil) in consulting fees to a company controlled by the Company's chief financial officer ("CFO") and \$7,500 (2011 Q1- \$Nil) in occupation expenditures (2011 Q1 - \$Nil) to a company controlled by a relative of a director.

On June 16, 2011, Maxtech advanced \$600,000 to the Company (the "Promissory Note") to meet the Company's operational cash requirements. The Promissory Note is unsecured and was discounted with an effective interest rate of 15% to \$546,529 at June 16, 2011, and was accreted up to \$586,422 and \$607,216 at December 31, 2011 and March 31, 2012 respectively. Principle and accrued interest of \$674,000 is due on December 31, 2012. Accretion accrued during the three months ended March 31, 2012 was \$20,794 (2011 Q1 - \$Nil).

As at March 31, 2012, the Company's accounts payable and accrued liabilities balance included \$1,680 balance owing to a company controlled by the Company's CFO. This related party payable is unsecured and has the same terms as other trade payables.

CHANGES IN ACCOUNTING POLICIES

The Company has not adopted new accounting standards since its last year ended December 31, 2011. Details about the new accounting standards issued not yet adopted are available at the Note 3 to the unaudited condensed interim financial statements for the three months ended March 31, 2012.

FINANCIAL INSTRUMENTS AND OTHER INSTRUMENTS

Refer to Notes 3 and 9 to the Company's audited annual financial statements for the year ended December 31, 2011 for details of the Company's financial instruments and related risk management policies.

RISK FACTORS

Risks of the Company's business include the following:

Mining Industry

The exploration for and development of mineral deposits involves significant risks, which even a combination of careful evaluation, experience and knowledge may not eliminate. While the discovery of an ore body may result in substantial rewards, few properties which are explored are ultimately developed into producing mines. Major expenses may be required to establish ore reserves, to develop metallurgical processes and to construct mining and processing facilities at a particular site. It is impossible to ensure that the current exploration programs planned by the Company will result in a profitable commercial mining operation. Whether a mineral deposit will be commercially viable depends on a number of factors, some of which are the particular attributes of the deposit, such as size, grade and proximity to infrastructure, as well as metal prices which are highly cyclical and government regulations, including regulations relating to prices, taxes, royalties, land tenure, land use, importing and exporting of minerals and environmental protection.

The exact effect of these factors cannot be accurately predicted, but the combination of these factors may result in the Company not receiving an adequate return on invested capital. Mining operations generally involve a high degree of risk. The Company's operations are subject to all the hazards and risks normally encountered in the exploration, development and production of ore, including unusual and unexpected geology formations, rock bursts, cave-ins, flooding and other conditions involved in the drilling and removal of material, any of which could result in damage to, or destruction of, mines and other producing facilities, damage to life or property, environmental damage and possible legal liability. Although adequate precautions to minimize risk will be taken, milling operations are subject to hazards such as equipment failure or failure of retaining dams around tailings disposal areas, which may result in environmental pollution and consequent liability.

The Company's mineral exploration activities are directed towards the search, evaluation and development of mineral deposits. There is no certainty that the expenditures to be made by the Company as described herein will result in discoveries of commercial quantities of ore. There is aggressive competition within the mining industry for the discovery and acquisition of properties considered to have commercial potential. The Company will compete with other interests, many of which have greater financial resources than it will have for the opportunity to participate in promising projects. Significant capital investment is required to achieve commercial production from successful exploration efforts.

Government Regulation

The exploration activities of the Company are subject to various federal, provincial and local laws governing prospecting, development, production, taxes, labour standards and occupational health, mine safety, toxic substance and other matters. Exploration activities are also subject to various federal, provincial and local laws and regulations relating to the protection of the environment. These laws mandate, among other things, the maintenance of air and water quality standards, and land reclamation. These laws also set forth limitations on the generation, transportation, storage and disposal of solid and hazardous waste.

Although the Company's exploration activities are currently carried out in accordance with all applicable rules and regulations, no assurance can be given that new rules and regulations will not be enacted or that existing rules and regulations will not be applied in a manner which could limit or curtail production or development. Amendments to current laws and regulations governing operations and activities of exploration, mining and milling or more stringent implementation thereof could have a substantial adverse impact on the Company.

Permits and Licenses

The exploitation and development of mineral properties may require the Company to obtain regulatory or other permits and licenses from various governmental licensing bodies. There can be no assurance that the Company will be able to obtain all necessary permits and licenses that may be required to carry out exploration, development and mining operations on its properties.

Environmental Risks and Hazards

All phases of the Company's mineral exploration operations are subject to environmental regulation in the various jurisdictions in which it operates. Environmental legislation is evolving in a manner which will require stricter standards and enforcement, increased fines and penalties for non-compliance, more stringent environmental assessments of proposed projects and a heightened degree of responsibility for companies and their officers, directors and employees.

There is no assurance that future changes in environmental regulation, if any, will not adversely affect the Company's operations. Environmental hazards may exist on the properties on which the Company holds interests which are unknown to the Company at present, which have been caused, by previous or existing owners or operators of the properties. The Company may become liable for such environmental hazards caused by previous owners and operators of the properties even where it has attempted to contractually limit its liability. Government approvals and permits are currently, and may in the future be, required in connection with the Company's operations. To the extent such approvals are required and not obtained; the Company may be curtailed or prohibited from proceeding with planned exploration or development of mineral properties.

Failure to comply with applicable laws, regulations and permitting requirements may result in enforcement actions there under, including orders issued by regulatory or judicial authorities causing operations to cease or be curtailed, and may include corrective measures requiring capital expenditures, installation of additional equipment, or remedial actions. Parties engaged in mining operations may be required to compensate those suffering loss or damage by reason of the mining activities and may have civil or criminal fines or penalties imposed for violations of applicable laws or regulations.

Amendments to current laws, regulations and permits governing operations and activities of mining companies, or more stringent implementation thereof, could have a material adverse impact on the Company and cause increases in exploration expenses, capital expenditures or production costs or reduction in levels of production at producing properties or require abandonment or delays in development of new mining properties. Production of mineral properties may involve the use of dangerous and hazardous substances such as sodium cyanide. While all steps will be taken to prevent discharges of pollutants into the ground water the environment, the Company may become subject to liability for hazards that cannot be insured against.

Commodity Prices

The profitability of mining operations is significantly affected by changes in the market price of gold and other minerals. The level of interest rates, the rate of inflation, world supply of these minerals and stability of exchange rates can all cause significant fluctuations in base metal prices. Such external economic factors are in turn influenced by changes in international investment patterns and monetary systems and political developments. The price of gold and other minerals has fluctuated widely in recent years, and future serious price declines could cause continued commercial production to be impracticable.

Depending on the price of gold and other minerals, cash flow from mining operations may not be sufficient. Any figures for reserves presented by the Company will be estimates and no assurance can be given that the anticipated tonnages and grades will be achieved or that the indicated level of recovery will be realized. Market fluctuations and the price of gold and other minerals may render reserves uneconomical. Moreover, short-term operating factors relating to the reserves, such as the need for orderly development of the ore bodies or the processing of new or different grades of ore, may cause a mining operation to be unprofitable in any particular accounting period.

Uninsured Risks

The Company may carry insurance to protect against certain risks in such amounts as it considers adequate. Risks not insured against include environmental pollution or other hazards against which such corporations cannot insure or against which they may elect not to insure.

Conflicts of Interest

Certain of the directors of the Company also serve as directors and/or officers of other companies involved in natural resource exploration and development. Consequently, there exists the possibility for such directors to be in a position of conflict. Any decision made by such directors involving the Company will be made in accordance with their duties and obligations to deal fairly and in good faith with the Company and such other companies. In addition, such directors will declare, and refrain from voting on, any matter in which such directors may have a conflict of interest.

Property Title

Although the Company has obtained title opinions with respect to certain of its properties, there may still be undetected title defects affecting such properties. Accordingly, such properties may be subject to prior unregistered liens, agreements, transfers or claims, and title may be affected by, among other things, undetected defects which could have a material adverse impact on the Company's operations.

FINANCIAL AND DISCLOSURE CONTROLS AND PROCEDURES

During the three months ended March 31, 2012, there has been no significant change in the Company's internal control over financial reporting since last year ended December 31, 2011.

The Company's certifying officers are responsible for ensuring that processes are in place to provide them with sufficient knowledge to support the representations they make. Investors should be aware that inherent limitations on the ability of the Company's certifying officers to design and implement on a cost effective basis DC&P and ICFR as defined in NI 52-109 may result in additional risks to the quality, reliability, transparency and timeliness of interim and annual filings and other reports provided under securities legislation.

In connection with Exemption Orders issued in November 2007 and revised in December 2008 by each of the securities commissions across Canada, the Chief Executive Officer and Chief Financial Officer of the Company will file a Venture Issuer Basic Certificate with respect to the financial information contained in the unaudited interim financial statements and the audited annual financial statements and respective accompanying Management's Discussion and Analysis.

In contrast to the certificate under National Instrument ("NI 52-109") (Certification of Disclosure in Issuer's Annual and Interim Filings), the Venture Issuer Basic Certification does not include representations relating to the establishment and maintenance of disclosure controls and procedures and internal control over financial reporting, as defined in NI 52-109.
