On January 15, 2020, the Acquiror acquired directly and indirectly a total of 2,185,340 common shares representing 2.18% of the issued common shares of Tartisan in a private transaction as a bequest from the estate of the Acquiror’s father. (the “**Transaction**”).

D. M. Appleby Holdings Inc., a corporation controlled by Mr. Appleby.

Prior to the transaction that gave rise to the obligation to file this report, the Acquiror had owned directly and indirectly 8,958,510 common shares representing 8.92% of the issued common shares of Tartisan.

On January 15, 2020 the Acquiror completed the transaction. As a result of the transaction the Acquiror owns directly or indirectly 11,143,750 common shares of Tartisan representing approximately 11.10 % of the company on a non-diluted basis.

Tartisan currently has no future intentions relating to the matters listed in clauses (a) to (k) above.
