Between January 17, 2020 and January 31, 2020, the Acquiror acquired directly and indirectly a total of 2,730,000 common shares representing 2.72 % of the issued common shares of Tartisan. (the “**Transaction**”).

Prior to the transactions that gave rise to the Acquiror's obligation to file this report, the Acquiror had owned directly and indirectly 11,143,750 common shares representing 11.10% of the issued and outstanding common shares of Tartisan. Subsequent to the January 17, 2020 Early Warning Report, the Acquiror purchased 2,730,000 additional shares being 2.72% of the issued and outstanding shares on a non-diluted basis. As a result of the transaction the Acquiror owns 13,873,750 shares being 13.82% of the issued and outstanding shares on a non-diluted basis.
