WINSTON ANNOUNCES \$250,000 NON-BROKERED PRIVATE PLACEMENT

Toronto, Ontario, July 16, 2012 - Winston Resources Inc. (CNSX: WRW) ("Winston") is pleased to announce that it intends to complete a non-brokered private placement (the "Private Placement") of 1,250,000 units (each a "Unit") of Winston at a price of \$0.20 per Unit, for gross proceeds of \$250,000. Each Unit consists of one common share in the capital of Winston and one common share purchase warrant. Each common share purchase warrant entitles the holder to acquire one additional common share in the capital of Winston at an exercise price of \$0.30, for 24 months after closing; provided, however, that in the event that the common shares trade on the CNSX at a closing price of greater than \$0.40 per share for a period of 10 consecutive trading days Winston may, in its sole discretion, accelerate the expiration date of the warrants.

The sole investor is an unrelated US private trust, and the securities will be issued pursuant to appropriate exemptions under the United States Securities Act of 1933, as amended, and will be subject to a hold period in Canada of four months and a day. The proceeds of the Private Placement will be used for working capital purposes.
