Winston Announces Share Consolidation for 1:3

Vancouver, B.C. – January 12, 2017 – **Winston Resources Inc. (CSE: WRW)** (the “Company” or “Winston”) will consolidate its issued and outstanding share capital on the basis of one (1) post-consolidation share for each three (3) pre-consolidation common shares. No fractional shares will be issued under the consolidation, and any fraction will be rounded to the nearest whole number.

As a result, the outstanding common shares of the company will be reduced to approximately 3,287,445 from 9,862,335 common shares. In connection with the consolidation, the name of the company will not change and the company’s trading symbol will remain as WRW.
