Vancouver, B.C., December 1, 2015. NU2U Resources Corp. (the “Company”) announces that Thomas Bell has resigned as Chief Executive Officer and Director and Patrick Lavin has resigned as Chief Financial Officer and Director. Lance Tracey has been appointed as Chief Executive Officer and Director and Sheri Rempel has been appointed as Chief Financial Officer and Director. Each of Mark Sampson and Laurie Baggio have also been appointed as Directors of the Company.

Lance Tracey co-founded Sutton Group, a Canadian Real Estate Franchise in 1983. Lance and Sutton have been early stage investors in many successful Internet startups over the years, including Look Communications, Internet Direct.
