On August 16, 2021, Emiral acquired ownership of 34,825,000 Subscription Receipts of the Company pursuant to a subscription agreement dated as of August 2, 2021, as amended as of August 16, 2021, at a subscription price of C\$1.00 per Subscription Receipt, for total cash consideration of C\$34,825,000. Upon satisfaction of certain release conditions, the Subscription Receipts will

automatically convert into 49,750,000 common shares of the Company at an implied subscription price of C\$0.70 per common share in the capital of the Company.

After giving effect to the conversion of 34,825,000 Subscription Receipts of the Company, the Acquiror will acquire ownership of 49,750,000 common shares of the Company representing approximately 19.9% of the issued and outstanding common shares of the Company on a non-diluted basis. Prior to the transaction that triggered the requirement to file this report, the Acquiror did not own any securities of the Company.
