COVER TECHNOLOGIES INC. CLOSES OVERSUBSCRIBED NON-BROKERED PRIVATE PLACEMENT

Vancouver, B.C., Canada – February 26, 2021 – Cover Technologies Inc. (the "**Company**" or "**COVER**") is pleased to announce that it has closed and increased its non-brokered private placement previously announced on February 12, 2021 (the "**Placement**"). Due to increased demand, the Placement was increased to 18,113,207 units (the "**Units**") at a price of \$0.265 per Unit, for gross proceeds of \$4,799,999.86.

Each Unit will consist of one common share in the capital of the Company (each a "Share") and one share purchase warrant (each a "Warrant"). Each Warrant will entitle the holder to acquire one additional Share at a price of CDN \$0.75 per Warrant for a period of two years from the applicable closing date, subject to an accelerated expiry provision described herein. If on any 10 consecutive trading days occurring after four months and one day has elapsed following the final closing date of the Placement, the closing price of the Shares as quoted on the Canadian Securities Exchange (the "CSE") (or such other exchange on which the Shares may be traded at such time) is greater than CDN \$1.00 per Share, Cover may provide notice in writing to the holders of the Warrants by issuance of a news release that the expiry date of the Warrants will be accelerated to the 30th day after the date on which Cover issues such news release.

Finder's fees were paid in connection with the Placement to arm's length finders (the "**Finders**") that consisted of cash commission in the total amount of \$294,041.99. In addition, an aggregate of 528,194 Shares and 602,398 Warrants (the "**Broker Warrants**") have been issued to the Finders. The terms of the Broker Warrants are identical to the terms of the Units.

Proceeds from the Placement are intended to be used to advance the Company's existing technology research & development projects, to expand the scope of its technology development to include online technology applications, and for general & administrative working capital. Although the Company intends to use the proceeds of the Placement as described above, the actual allocation of proceeds may vary from the uses set out above depending on future operations, events or opportunities.

The Shares and Warrants comprising the Units issued pursuant to the Placement will be subject to a statutory four month and one day hold period from the date of issue in accordance with applicable Canadian securities laws. None of the Units will be registered under the United States Securities Act of 1933, as amended, and none may be offered or sold in the United States absent registration or an applicable exemption from the registration requirements. This press release shall not constitute an offer to sell or the solicitation of an offer to buy any securities of the Company, nor shall there be any sale of the securities in any jurisdiction in which such offer, solicitation or sale would be unlawful.

Services Agreements for Digital Marketing

The company further announces that it has engaged Hyperdrive Interactive ("Hyperdrive") to lead digital marketing campaigns for the Company with an objective of gaining a better understanding of its target audience, leveraging cutting-

edge technologies such as ExactTarget (now Salesforce Marketing Cloud) and the Salesforce suite of tools. Hyperdrive was founded in 2001 and is based in Cincinnati, Ohio. In connection with HyperDrive's engagement, the Company has entered into a services agreement with Hyperdrive, pursuant to which it will primarily be tasked with providing the following services:

Digital marketing services to increase public awareness of and interest in the Company.

The services agreement with Hyperdrive has a six-month term effective March 15, 2021 with a total payment value of USD\$131,250.

Cover has also engaged Young & Digital Holdings Inc. ("Y&D") to create webpages, form strategies for driving conversions, and execute digital promotions. Taking a holistic approach to digital marketing, Y&D incorporates technologies and tactics to include artificial intelligence, A/B testing, and retargeting of advertisements. Y&D has offices in both Canada (Vancouver) and Germany (Munich). In connection with Y&D's engagement, the Company has entered into a service agreement with Y&D, pursuant to which it will primarily be tasked with providing the following services:

Web development, strategic planning, forming and executing advertising campaigns for the Company.

The services agreement with Y&D has a six-month effective March 15, 2021 with a total payment value of CAD\$285,000 plus applicable taxes.

Lastly, Cover has engaged Think Ink Marketing Data and Email Services ("**Think Ink**") to provide and manage a public relations campaign for the Company, to increase public awareness of the Company and its products, services, and securities. In connection with Think Ink's engagement, the Company has entered into a public relations services agreement with Think Ink, pursuant to which it will primarily be tasked with providing the following services:

Carrying out a public relations campaign to increase public awareness of the Company and its products, services, and securities.

The services agreement with Think Ink has a six-month term effective March 15, 2021 with a total payment value of USD\$250,000.
