Common shares (each, a "Share") of Phoenix Gold Resources Corp.

The issuer is Phoenix Gold Resources Corp. (the "Issuer"), with a head office at Suite 1518 – 800 West Pender Street, Vancouver, British Columbia, V6C 2V2.

1.2 State the name of the market in which the transaction or other occurrence that triggered the requirement to file this report took place.

The transaction that triggered the requirement to file this report was the acquisition of Shares as part of a debt settlement, pursuant to which the Issuer issued 18,346,780 Shares at a price of \$0.05 per Share to settle indebtedness in the total aggregate amount of \$917,339, which closed on August 18, 2020 (the "Debt Settlement"). The transaction did not take place on a market.

The acquiror acquired 3,750,000 Shares as part of the Debt Settlement.

As a result of the Debt Settlement, the acquiror holds 3,823,469 common shares in the capital of the Issuer, which represents 13.96% of the Issuer's 27,385,762 issued and outstanding common shares on both a non-diluted and diluted basis, as there are no convertible securities of the Issuer outstanding.

Immediately before the completion of the Debt Settlement, the acquiror beneficially owned and controlled a total of 73,469 common shares in the capital of the Issuer, representing 0.81% of the Issuer's issued and outstanding common shares on a non-diluted and diluted basis.

Immediately after the completion of the Debt Settlement, the acquiror beneficially owned and controlled a total of 3,823,469 common shares, representing 13.69% of the Issuer's issued and outstanding common shares on a non-diluted and diluted basis.

The acquiror settled a debt in the aggregate amount of \$187,500 owing from the Issuer to the acquiror at a price of \$0.05 per Share.

The 3,750,000 Shares were acquired by the acquiror pursuant to a debt settlement agreement containing the same standard terms as the debt settlement agreement entered into by other creditor of the Issuer who participated in the Debt Settlement, wherein Shares were issued as full and final settlement of indebtedness owing by the Issuer to the creditor at a price of \$0.05 per Share.
