Each Warrant comprising part of a Unit entitles the holder thereof to acquire one Share at a price of \$0.60 per Share until two years after the issuance of the Warrant. The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.
