This Management Discussion and Analysis ("MD&A") of the consolidated financial condition, results of operations, and cash flows of Phoenix Gold Resources Corp. ("PXA" or the "Company") are for the year ended January 31, 2021. This MD&A should be read in conjunction with the Company's audited consolidated financial statements and related notes thereto for the years ended January 31, 2021 and 2020.

The financial information in this MD&A is derived from the Company's audited consolidated financial statements which have been prepared in Canadian dollars unless otherwise noted, in accordance with International Accounting Standards as issued by the International Accounting Standards Board. The content of this MD&A has been approved by the Board of Directors, on the recommendation of its Audit Committee. This MD&A is dated May 31, 2021 and is current to date, unless otherwise noted.

Yingting (Tony) Guo, PhD., P. Geo of C2 Mining International Corp., a Qualified Person as defined by National Instrument 43-101, is responsible for the Company's most recent technical report dated September 15, 2020.

DESCRIPTION OF BUSINESS

Phoenix Gold Resources Corp. (formerly Zuri Capital Corp. ("Zuri")) was incorporated on May 2, 2011 under the laws of the province of British Columbia, Canada. The Company is a TSX Venture Exchange ("Exchange") Tier 2 listed mineral exploration and development company with its principal business focusing on the acquisition and exploration of the gold mineral rights located in Nevada, USA. The Company has not yet determined whether the property contains mineral reserves that are economically recoverable.

On July 9, 2013, The Company acquired a 50% right, title, and interest to the Plumas Property and the Company also entered into a 20-year renewable lease for the remaining 50% right, title, and interest to the Plumas Property. The Plumas Property consists of two patented lode mining claims with extra lateral rights (40 acres) and one patented mill site claim (8.5 acres) situated in Battle Mountain, Lander County, Nevada, USA. The Company also acquired a 50% right, title, and interest to the Eldorado Property. The Eldorado Property consists of one patented lode mining claim (20 acres) named Eldorado situated in Battle Mountain, Lander County, Nevada, USA.

Zuri entered into a letter of agreement dated July 29, 2013 (the "Letter Agreement") which was amended on October 8, 2013, November 14, 2013, December 2, 2013, December 16, 2013, January 21, 2014, and February 21, 2014, with Phoenix, a private corporation incorporated in the province of British Columbia on March 11, 2013. On April 23, 2014, Zuri and Phoenix completed a reverse takeover transaction (the "RTO Transaction") which has been accounted for as a reverse takeover of net assets in accordance with the Company's accounting policies on reverse takeover transactions that do not constitute business combinations. As a result, Zuri carries on the business of Phoenix and continues pursuant to the laws of British Columbia effective April 23, 2014 with respect to the RTO Transaction. Zuri changed its name to "Phoenix Gold Resources Corp." effective April 23, 2014. Also effective April 25, 2014, Zuri resumed trading on the Exchange with the trading symbol "PXA".

On February 26, 2021, the Company entered into an option agreement with WBN Prospecting Group to acquire a 100% interest in the York Harbour Property ("York Harbour" or the "Property"), consisting of

five mineral licences and 156 mineral claims totalling 3,900 hectares. The property is located 27km west of the city of Corner Brook, Newfoundland and is accessible by a provincial highway (Route 450). The Company made a cash payment of \$95,000 and issued 1,485,557 shares of the Company as part of this transaction.

On April 12, 2021, the Company signed a Letter Of Intent (LOI) with ENE-MIN Development Corp. for an exclusive option to acquire up to 75% interest in the LiBeGa Lithium Project, comprising adjoining perimeters (concessions or mineral claims) covering a total of 27km² in Sibiu County, Romania (the "Property"). Pursuant to the LOI, the Company paid a refundable \$250,000 good faith due diligence deposit and has initiated an exclusive comprehensive confidential evaluation of the Project.

CORPORATE

Effective November 5, 2014, Mr. William Matlack resigned from the Board of the Company.

Effective March 22, 2019, Mr. Walter Davidson was appointed as a Director of the Company and Mr. Glenn Laing resigned from the Board of the Company.

Effective August 6, 2020, Mr. Andrew Lee replaced Mr. Paul Jones as the Company's President and Chief Executive Officer.

Effective September 18, 2020, Mr. Roger Baer was appointed as a Director of the Company and Mr. Paul Jones resigned from the Board of the Company.

TECHNICAL

PHOENIX GOLD PROJECT

Location

The Phoenix Gold Project properties are located in Lander County, Nevada. The properties are approximately 15 miles south of Battle Mountain, Nevada, and are adjacent to Newmont's Fortitude gold mine. The Phoenix Gold Project consists of Plumas Property and Eldorado Property, including three (3) patented mining claims and 1 patented mill site claim with a total area of 24.48 hectares in Battle Mountain, Nevada.

A National Instrument 43-101 technical report (the "Technical Report") entitled "NI 43-101 TECHNICAL REPORT ON THE PHOENIX GOLD PROJECT LANDER COUNTY, NEVADA, USA" was completed by C2 Mining International Corp. on September 15, 2020 and is available on SEDAR. The recommendations in the Technical Report suggests further work is warranted at the Plumas Property to further outline and define known mineralization at Plumas Property with additional drilling and sampling. Drill targets need to be generated at the Eldorado Property through additional sampling programs.

York Harbour Mine Property

York Harbour Mine Property ("York Harbour Mine" or the "YHM Property"), consists of five mineral licences and 156 mineral claims totalling 3,900 hectares; located 27 km west of the city of Corner Brook, Newfoundland and is accessible by a provincial highway (Route 450). The deposit at York Harbour comprises a series of stratabound, Cyprus-type volcanogenic Cu-Zn massive sulphide lenses, hosted by simply folded ophiolitic mafic volcanic rocks of the Bay of Islands Complex. Earliest reported production is from 1898 to 1913 which amounted to approximately 90,000 tons of ore grading 3-12% copper and 7% zinc being extracted according to the Mineral Occurrence Database System Report website for Labrador and Newfoundland.

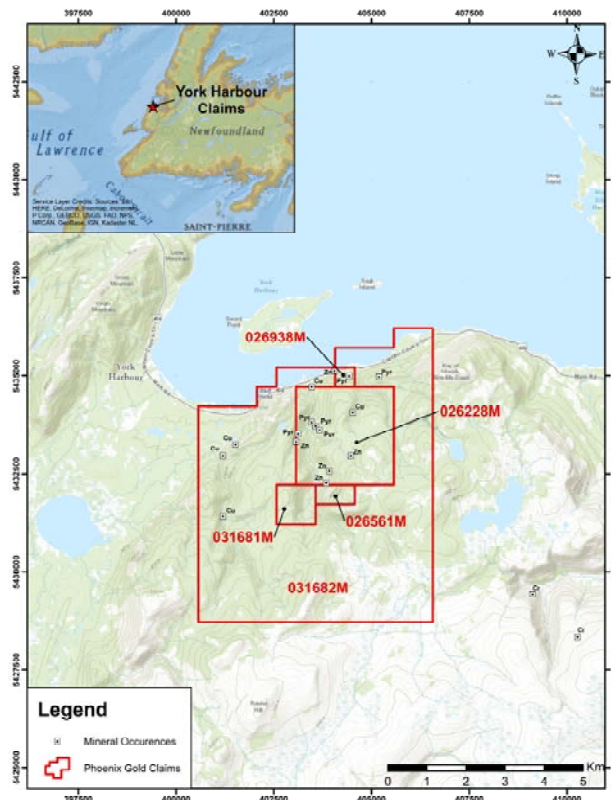


Figure 1. York Harbour Mine Property Claims Licence Boundary

Mineralization documented on the property exhibits characteristics consistent with classic mafic-type flow dominated (Cyprus type) volcanogenic massive sulphide deposits. Similar geological environments and styles of mineralization have formed relatively large copper-zinc deposits elsewhere in Newfoundland at Tilt Cove (nine million tonnes of between 1 per cent and 12 per cent copper) and in Cyprus at the Mavrovouni mine (15 million tonnes of 4 per cent copper with zinc and gold).

Extensive exploration by various companies have been carried out on the Property including over 10,900 metres of underground drilling and 8,200 metres of drilling from surface; airborne and ground geophysical surveys; geological mapping; and geochemical sampling over the years which has resulted in the discovery of eleven lenses ("zones") of copper-zinc enriched massive sulphides for which several resource estimates have been calculated (Table 1).

**These resource estimates are historical in nature. A qualified person has not done sufficient work to classify these historical estimate as current mineral resources or mineral reserves, and Phoenix Gold is not treating them as such.*

Phoenix Gold can acquire its 100% interest from the Optionor subject to a 2% net smelter returns royalty ("NSR") on the following terms:

- 1) payment of \$95,000 cash; (paid)
- 2) the issuance of 1,485,566 shares of Phoenix Gold; (issued)
- 3) incurring \$3,000,000 in Exploration Expenditures as follows:
 - a. \$250,000 on or before the first anniversary;
 - b. \$750,000 accumulated total on or before the second anniversary; and
 - c. \$3,000,000 accumulated on or before the third anniversary.

The Company has the right to purchase from the Optionor 1% of the NSR, within one year of commencement of Commercial Production at a cost of \$1,000,000.

The field work planned for 2021 will comprise borehole geophysical surveying, exploration diamond drilling, and evaluate the possibility of re-entering the underground mine workings. While the geophysical survey is being carried out the GPS locations, downhole orientations, geological information and drill core sampling results are being collated and entered into a Gemcom 3D modelling database for later drill hole planning and siting.

Exploration target drilling will begin in June following a thorough review of the 3D modelling and Pulse EM geophysical results plus approval and receipt of the required permit for drilling. The first one or two prioritized drill holes will be sited to twin and validate historic drill results. Subsequent drilling locations will test high-priority geological and geophysical exploration targets within both the York Harbour Mine area and other poorly tested or unexplored targets.

Recently the exploration team visited the Property for site evaluation and examined an outcrop of ‘A’ Zone mineralization, located along Copper Mine Brook. Eleven grab samples and 3 continuous chip samples in 1 m intervals were collected along a 100m strike. These samples have since been sent to Eastern Analytics in Springdale, NL for ore grade assays. Other planned work includes a combined re-logging and re-sampling work on the drill cores from seven historic drill holes, totaling 1,586 meters (Wolfden Resources c. 2004-2005), that are currently in storage at Newfoundland’s Core Storage Building in Pasadena, NL

RESULTS OF OPERATIONS AND SELECTED FINANCIAL INFORMATION

As at January 31, 2021, the Company had working capital of \$1,014,862 (January 31, 2020 – negative working capital of \$1,417,593), and reported a deficit of \$3,400,826 (January 31, 2020 – \$3,321,942).

For the three months ended January 31, 2021

The Company's net loss and comprehensive loss for the three months ended January 31, 2021 was \$143,689 (2020 – \$367,047). Management and consulting fees totalled \$68,808 (2020 – \$nil). The increase in management and consulting fees was due to a significant increase in business development activities of the Company undertaken by the Company's management and consultant during the quarter compared to the prior comparative quarter. Professional fees totalled \$24,213 (2020 – \$89,229). Professional fees decreased significantly during the quarter because of a reduction in legal fees related to corporate and financing activities during the quarter compared to the prior comparative quarter. Office and administration expenses totalled \$23,009 (2020 – \$1,535). The main reason for the increase in office and administration expenses during the quarter was due to office rent paid for the new headquarters of the Company starting in June 2020. Filing fees totalled \$13,120 (2020 – \$250). The increase in filing fees was due to additional TSX Venture filings that were required during the quarter compared to the prior comparative quarter. Foreign exchange loss totalled \$6,624 (2020 – \$1,199) due to unfavourable fluctuations in the value of Canadian dollar as compared to the United States dollar during the quarter. Exploration expenses of \$7,989 (2020 – \$nil) related to geological consulting fees on its Plumas and Eldorado properties incurred and expensed by the Company during the quarter.

For the year ended January 31, 2021

The Company's net loss and comprehensive loss for the year ended January 31, 2021 was \$78,884 (2020 – \$540,171). Management and consulting fees totalled \$113,808 (2020 – \$nil). The increase in management and consulting fees was due to a significant increase in business, corporate, and financing activities of the Company undertaken by the Company's management and consultants during the year compared to the prior comparative year. Professional fees totalled \$67,958 (2020 – \$232,148). Professional fees decreased significantly during the year because of a reduction in legal fees related to corporate and financing activities during the year compared to the prior comparative year. Office and administration expenses totalled \$39,185 (2020 – \$9,375). The main reason for the increase in office and administration expenses during the year was due to office rent paid for the new head office of the Company starting in June 2020. Filing fees totalled \$12,427 (2020 – \$23,301). The decrease in filing fees compared to the prior comparative year was due to fewer filing activities during the year and a non-recurring credit that the Company received for unused services from the prior year. Foreign exchange loss totalled \$8,094 (2020 – \$513) due to unfavourable fluctuations in the value of Canadian dollar compared to the United States dollar during the year. Exploration expenses totalled \$7,989 (2020 – \$nil) and were related to geological consulting fees on its Plumas and Eldorado properties incurred and expensed by the Company during the year. Gain on debt settlements totalled \$107,503 as the Company was successful in settling old debts with a few creditors at a discounted amount during the year.

OFF BALANCE-SHEET ARRANGEMENTS

The Company has no off balance-sheet arrangements.

LIQUIDITY AND CAPITAL RESOURCES

The Company has historically relied upon equity financing and loans from directors to satisfy its capital requirements and will continue to depend heavily upon equity capital to finance its activities. There can be no assurance the Company will be able to obtain the required financing in the future on acceptable terms.

The Company has limited financial resources, no source of operating income and no assurance that additional funding will be available to it for current or future projects, although the Company has been successful in the past in financing its activities through the sale of equity securities. The ability of the Company to arrange additional financing in the future will depend, in part, on the prevailing capital market conditions and its exploration success. Any quoted market for the Company's shares may be subject to market trends generally, notwithstanding any potential success of the Company in creating revenue, cash flows or earnings.

As at January 31, 2021, the Company had the following contractual arrangements and commitments in place for the provision of certain services:

- a) As part of the letter of agreement entered into with AGEI and Matlack on July 9, 2013 and as amended on October 29, 2013, December 16, 2013, January 21, 2014, and February 21, 2014 for the acquisition of certain patented mineral claims in Nevada, comprised of the Eldorado Property, the Plumas Property (collectively, the "Phoenix Gold Properties"), the Company has the following commitment:
 - (i) As part of the lease of the Plumas Property describe in note 4, the Company is required to make annual payments of \$44,730 (US\$35,000) on each anniversary date of April 23, 2014 for a period of 20 years. Future minimum lease payments are as follows:

The Company is currently in default of the Plumas Lease for failure to pay the 2015, 2016, 2017, 2018, 2019, and 2020 payment amounts under the terms of the lease and if the Company remains in default, Matlack may terminate the lease resulting in a loss of a 50% leasehold interest in the Plumas Property. The Company currently does not have sufficient funds to allocate for lease payments under the Plumas Lease.

- b) On April 13, 2019, the company entered into a binding letter of intent with Fox Automotive Switzerland AG, pursuant to which the Company will acquire all issued and outstanding shares in the capital of Fox, subject to approval of the shareholders of the Company and the TSXV. On April 29, 2020, the letter of intent with Fox was terminated since the proposed transaction was not completed in the time allowed under the letter of intent.
- c) On August 18, 2020, the Company settled \$963,127 owing to officers and director of the Company by issuing 18,346,780 shares at a deemed price of \$0.05 per share.
- d) On August 25, 2020, the Company negotiated and settled a total of \$142,028 in accounts payable owing to third party creditors of the Company by making one time cash payments in the total amount of \$17,313. The Company recognized a gain on debt settlement of \$124,715 on this transaction.

FINANCING ACTIVITIES

On March 22, 2019, the Company approved the consolidation of all issued and outstanding common shares on the basis of seven (7) to one (1) (the "Consolidation"), which was approved by the TSX Venture Exchange (the "TSXV") and completed on April 3, 2019. As a consequence of the Consolidation, the issued and outstanding common shares (the "Common Shares") of the Company were consolidated from 35,272,900 to 5,038,986 Common Shares.

On August 21, 2019, 264,286 stock options originally issued on August 22, 2014 expired unexercised.

On July 31, 2020, the Company issued 4,000,000 common shares of the Company at a price of \$0.05 per common share for gross proceeds of \$200,000.

On August 18, 2020, the Company closed a debt settlement with related parties of the Company in the aggregate amount of \$917,339 by a way of shares for debt transaction at a price of \$0.05 per common share of the Company for a total aggregate of 18,346,780 shares. All shares issued pursuant to the debt settlement is subject to a four month hold period from the date of issue.

On December 18, 2020, the Company completed a non-brokered private placement offering (the "Private Placement") raising gross proceeds of \$1,400,000 through the sale of 7,000,000 units ("Units") of the Company at a price of \$0.20 per unit. Each Unit consists of one common share (a "Share") and one-half common share purchase warrant (each such full warrant, a "Warrant") which is exercisable for a period of

24 months from the closing of the Private Placement. Each Warrant entitles the holder to purchase a Share at a price of \$0.50 per Share if exercised within the first 12 months, and at \$0.75 per Share after 12 months but within 24 months following the closing date. A cash finders' fee in the total aggregate amount of \$6,000 was paid in respect of the Private Placement. All Shares issued pursuant to the Private Placement are subject to a four month hold period from the date of issue.

On February 26, 2021, the Company entered into an option agreement with WBN Prospecting Group to acquire a 100% interest in the York Harbour Property ("York Harbour" or the "Property"), consisting of five mineral licences and 156 mineral claims totalling 3,900 hectares. The property is located 27km west of the city of Corner Brook, Newfoundland and is accessible by a provincial highway (Route 450). The Company made a cash payment of \$95,000 and issued 1,485,566 shares of the Company as part of this transaction.

On March 31, 2021, the Company completed a non-brokered private placement to raise \$1,000,000 by issuing 2,500,000 units of the Company at a price of \$0.40 per unit. Each unit is comprised of one common share and one full warrant of the Company. Each warrant is exercisable at a price of \$0.60 per share for a period of 24 months from the date of issuance.

As of January 31, 2021, the Company had advances from an officer and director of the Company, in the amount of \$10,816 (2020 - \$nil). The advances are non-interest bearing, unsecured, and have no fixed term of repayment.

As of January 31, 2021, the Company had advances from a related company, which is owned and controlled by an officer and director of the Company, in the amount of \$nil (2020 - \$359,839). The advances are non-interest bearing, unsecured, and have no fixed term of repayment.

On August 18, 2020, the Company issued a total of 14,596,780 shares at a deemed price of \$0.05 per share to settle \$359,839 in advances from a company controlled by an officer and director of the Company, and \$370,000 in accounts payable owing to an officer and director of the Company.

These transactions are in the normal course of operations and at the exchange amount agreed to by the related parties.

FINANCIAL INSTRUMENTS

As at January 31, 2021, the Company's financial instruments consist of cash, other receivables, prepaid expenses, accounts payable and accrued liabilities, advances from related party, and advances from related company. These financial instruments are classified as other financial liabilities and are carried at amortized cost. The fair values of these financial instruments approximate their carrying values due to the short-term nature of these instruments.

The Company's risk management policies are established to identify and analyze the risks faced by the Company, to set appropriate risk limits and controls, and to monitor risks and adherence to market conditions and the Company's activities. The Company has exposure to credit risk, liquidity risk and market risk as a result of its use of financial instruments. Refer to Note 12 within the audited consolidated financial statements for the years ended January 31, 2021 and 2020 regarding information about the Company's exposure to each of the above risks and the Company's objectives, policies and processes for measuring and managing these risks.

The Company's critical accounting estimates are defined as those estimates that have a significant impact on the portrayal of its financial position and operations and that require management to make judgements, assumptions and estimates in the application of IFRS. Judgments, assumptions and estimates are based on historical experience and other factors that management believes to be reasonable under current conditions. As events occur and additional information is obtained, these judgements, assumptions and estimates may be subject to change. The Company's significant accounting policies can be found in Note 3 of the Company's audited consolidated financial statements. The following critical accounting estimates were used in the preparation of its consolidated financial statements.

Use of estimates

The preparation of financial statements in conformity with IFRS requires management to make judgements, estimates and assumptions that affect the application of the accounting policies to financial information presented. Actual results may differ from the estimates, assumptions and judgements made. Estimates and underlying assumptions are reviewed on an ongoing basis. Changes made to estimates are reflected in the period the changes are made.

Significant areas requiring the use of estimates and assumptions include accounts payable and accrued liabilities, valuation of share-based payment reserves, warrant reserves, valuation of short-term

By their nature, these estimates and assumptions are subject to measurement uncertainty, and the impact of changes in estimates in the financial statements of future period could be material. These assumptions are reviewed periodically and, as adjustments become necessary, they are reported in earnings (loss) in the periods in which they become known.

Intangible assets: mineral rights

Under IFRS, the Company defers all cost relating to the acquisition and exploration of its mineral properties after the legal right to explore a property has been obtained, but before technical feasibility and commercial viability of the property has been established. Any revenues received from such properties are credited against the costs of the property. When commercial production commences on any of the Company's properties, any previously capitalized costs would be charged to operations using unit-of-production method. The Company reviews the carrying value of its mineral properties for recoverability when events or changes in circumstances indicate that the properties may be impaired. If such a condition exists and the carrying value of a property exceeds the estimated net recoverable amount, provision is made for the impairment in value.

The existence of uncertainties during the exploration stage and the lack of definitive empirical evidence with respect to the feasibility of successful commercial development of any exploration property does create measurement uncertainty concerning the estimate of the amount of impairment to the value of any mineral property. The Company relies on its own or independent estimates of further geological prospects of a particular property and also considers the likely proceeds from a sale or assignment of the rights before determining whether or not impairment in value has occurred.

For the purpose of impairment testing, assets are grouped together into the smallest group of assets that generates cash inflows from continuing use that are largely independent of the cash inflows of other assets or groups of assets (the "cash-generating unit" or "CGU"). The allocation of the Company's assets into CGUs requires judgement. A CGU recoverable amount is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value, using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which estimates of future cash flows have not been adjusted. If the recoverable amount of an asset or CGU is estimated to be less than its carrying amount, the carrying amount is reduced to the recoverable amount. Impairment is recognized immediately in profit or loss. Where an impairment subsequently reverses, the carrying amount is increased to the revised estimate of recoverable amount but only to the extent that this does not exceed the carrying value that would have been determined if no impairment had previously been recognized.

Share-based payment

The Company uses the fair value method, utilizing the Black-Scholes pricing model, for valuing stock options granted to directors, officers, and consultants. The estimated fair value is recognized over the applicable vesting period as stock-based compensation expense and an increase to share-based payment reserve. Any consideration paid by employees on the exercise of stock options or purchase of stock is credited to share capital plus the amounts originally recorded as share-based payment reserve. The fair value of options is estimated using the Black-Scholes pricing model based on estimates and assumptions for expected life of the options, expected volatility, risk-free interest rate and dividend yield. By their nature, these estimates are subject to measurement uncertainty and the effect on the financial statements of changes in such estimates could be material in future periods.

The Company uses the fair value method, utilizing the Black-Scholes pricing model, for valuing warrants. The fair value of warrants is estimated using the Black-Scholes pricing model based on estimates and assumptions for expected life of the warrants, expected volatility, risk-free interest rate and dividend yield. By their nature, these estimates are subject to measurement uncertainty and the effect on the financial statements of changes in such estimates could be material in future periods.

Fair value of equity settled transaction

IFRS 2 recommends that an entity shall measure any equity-settled share-based payment transactions directly at the fair value of the goods or services received. The Company issued warrants and options as part of the private placements and compensation payments to agents and brokers. The Company determined that the fair value of services received is not reliably measurable because the warrants attached to these transactions are not from the result of any services purchased by the Company. Also, fair values of services from agents and brokers are not reliably determinable because there is no similar open market for the services they provide, and the compensation is not based on a fixed market rate, but rather subject to negotiation by management. Lastly, it is common for exploration stage companies to provide share-based compensation as part of its equity and debt transactions in addition to a cash component. As such, management determined that the fair value of warrants rather than the fair value of services received should be used to determine the fair value of share-based transactions.

Income tax

The future income tax provision is based on the liability method. Future income taxes arise from the recognition of the tax consequences of temporary differences by applying enacted or substantively enacted tax rates applicable to future years of differences between the financial statement carrying amounts and the tax bases of certain assets and liabilities. The Company records a valuation allowance against any portion of those future income tax assets to the extent that it is more than likely that future income tax assets will not be realized. As a result, future earnings are subject to significant management judgement.

Standards issued but not yet effective

The standards and interpretations that are issued, but not yet effective, up to the date of authorization of these consolidated financial statements are disclosed below. Management anticipates that all of the pronouncements will be adopted in the Group's accounting policy for the first period beginning after the effective date of the pronouncement. Information on new standards, amendments and interpretations that are expected to be relevant to the Group's financial statements is provided below. Certain other new standards and interpretations have been issued but are not expected to have a material impact on the Company's consolidated financial statements.

RISKS AND UNCERTAINTIES

The Company's securities should be considered a highly speculative investment and investors should carefully consider all of the information disclosed in the Company's Canadian regulatory filings prior to making an investment in the Company.

General

Resource exploration and development is a speculative business, characterized by a number of significant risks including, among other things, unprofitable efforts resulting not only from the failure to discover mineral deposits but also from finding mineral deposits, which, though present, are insufficient in quantity and/or quality to return a profit from production.

The Company is in the resource sector and as such is exposed to a number of risks and uncertainties that are not uncommon to other companies in the same industry. Some of the current risks include the following:

- (a) The Company has no history of earnings and will not generate earnings until production commences;

- the likelihood of cost estimates increasing in the future; and
- the possibility of difficulties procuring needed supplies of electrical power and water.

Most exploration projects do not result in the discovery of mineral resources and no assurance can be given that any particular level of recovery of mineral resources will in fact be realized or that any identified resource will ever qualify as a commercially mineable (or viable) resource which can be legally and economically exploited. Estimates of reserves, mineral deposits and production costs can also be affected by such factors as environmental permit regulations and requirements, weather, environmental factors, unforeseen technical difficulties, unusual or unexpected geological formations and work interruptions. In addition, the grade of mineral resource ultimately discovered may differ from that indicated by drilling results. There can be no assurance that mineral resource recovered in small-scale tests will be duplicated in large-scale tests under on-site conditions or in production scale.

Mineral exploration and development involves a high degree of risk and few properties that are explored are ultimately developed into producing mines. The long-term profitability of the Company's operations will be related to the cost and success of its exploration programs, which may be affected by a number of factors beyond the Company's control.

Mineral exploration involves many risks, which even a combination of experience, knowledge and careful evaluation may not be able to overcome. Operations in which the Company has a direct or indirect interest will be subject to all the hazards and risks normally incidental to exploration, development and production of mineral resources, any of which could result in work stoppages, damage to property, and possible environmental damage.

The economics of developing mineral properties is affected by many factors including the costs of operations, fluctuations in markets, allowable production, importing and exporting of minerals and environmental protection.

Political Risk

The Company's Phoenix Gold Properties are located in Nevada, USA and York Harbour Mine Property is located in Newfoundland, Canada, and the Company will be subject to changes in political conditions and regulations in those countries. The Company's activities are subject to extensive laws and regulations governing worker health and safety, employment standards, waste disposal, protection of historic and archaeological sites, mine development, protection of endangered and protected species and other matters.

Regulators in the USA and Canada have broad authority to shut down and/or levy fines against facilities that do not comply with regulations or standards. The Company's mineral exploration and mining activities in the USA and Canada may be adversely affected in varying degrees by changing government regulations relating to the mining industry or shifts in political conditions that increase the costs related to the Company's activities or maintaining its licenses. by government regulations with respect to restrictions on production, price controls, export controls, income taxes, and expropriation of property, environmental legislation and mine safety.

A number of other approvals, licenses and permits may be required for various aspects of mine development. While the Company will use its best efforts to ensure title to the licenses and access to surface rights continue into the future, these titles or rights may be disputed, which could result in costly litigation or disruption of operations. The Company is uncertain if all necessary permits will be maintained on acceptable terms or in a timely manner. Future changes in applicable laws and regulation or changes in their enforcement or regulatory interpretation could negatively impact current or planned exploration and development activities on the Phoenix Gold Properties and York Harbour Mine Property. Any failure to comply with applicable laws and regulations or failure to obtain or maintain permits, even if inadvertent, could result in the interruption of exploration and development operations or material fines, penalties or other liabilities.

Financing Risks

Although the Company was able to obtain adequate financing in the past, there is no assurance that the Company will continue to obtain adequate financing in the future or that the terms of such financing will be favourable. Failure to obtain such additional financing could result in delay or indefinite postponement of further exploration and development of its projects with the possible loss of such properties.

Fluctuating Price and Currency

The Company raises its equity primarily in Canadian dollars and will conduct its principal business and operation activities in and proposes to maintain certain accounts in Canadian dollars and United States dollars ("US dollars"). The Company's operations in the USA make it subject to foreign currency fluctuation and such fluctuations may adversely affect the Company's financial position and operating results.

Foreign Countries and Regulatory Requirements

Even if the Phoenix Gold Properties and York Harbour Mine Property are proven to host economic reserves of gold and/or other mineral resources, factors such as governmental expropriation or regulation may prevent or restrict mining of any such deposits or repatriation of profits. Any changes in regulations or shifts in political conditions in the USA and Canada are beyond the control of the Company and may adversely affect its business. Operations may be affected in varying degrees by government regulations with respect to restrictions on production, price controls, export controls, income taxes, expropriation of property, environmental legislation and mine safety.

Uninsurable Risk

In the course of exploration, development and production of mineral properties, certain risks, and in particular, unexpected or unusual geological operating conditions including rock bursts, cave-ins, fires, flooding and earthquakes may occur. It is not always possible to fully insure against such risks and the Company may decide not to take out insurance against such risks as a result of high premiums or other reasons. No Assurance of Surface Rights

Permits and Licenses

The operations of the Company may require licenses and permits from various governmental authorities. There can be no assurance that such licenses and permits as may be required to carry out exploration, development and mining operations at its projects will be granted.

Competition

The mineral industry is intensely competitive in all its phases. The Company competes with many companies processing greater financial resources and technical facilities than itself for the acquisition of mineral concessions, claims, leases and other mineral interests as well as for the recruitment and retention of qualified employees and service providers. Factors beyond the control of the Company may affect the marketability of mineral substances discovered. These factors include market fluctuations, the proximity and capacity of natural resource markets and processing equipment, government regulations, including regulations relating to prices, taxes, royalties, land tenure, land use, importing and exporting of minerals and environmental protection. The exact effect of these factors cannot be accurately predicted, but the combination of these factors may result in the Company not receiving an adequate return on invested capital or losing its investment capital.

Environmental Risk

The Company's operations may be subject to environmental regulations promulgated by government agencies from time to time. Environmental legislation provides for restrictions and prohibitions on spills, releases or emissions of various substances produced in association with certain mining industry operations, such as seepage from tailings disposal areas, which could result in environmental pollution. A breach of such legislation may result in imposition of fines and penalties. In addition, certain types of operations require the submission and approval of environmental impact assessments.
