1. Nature and continuance of operations

Bethpage Capital Corp. (the "Company") was incorporated pursuant to the Business Corporations Act of British Columbia on May 13, 2010. The Company is a resource exploration company that is acquiring and exploring mineral properties. The Company is domiciled in Canada and its registered office is at Suite 717 – 1030 West Georgia Street, Vancouver, BC.

Pursuant to a prospectus filed with the British Columbia and Alberta Securities Commissions, the Company completed an Initial Public Offering ("IPO") on June 19, 2012 and its shares were listed for trading on the TSX Venture Exchange (the "Exchange"), as a Tier 2 issuer on June 21, 2012.

These condensed interim financial statements have been prepared on the assumption that the Company will continue as a going concern, meaning it will continue in operation for the foreseeable future and will be able to realize assets and discharge liabilities in the ordinary course of operations. As at September 30, 2016, the Company had not advanced its property to commercial production and is not able to finance day to day activities through operations. The Company's continuation as a going concern is dependent upon the successful results from its mineral property exploration activities and its ability to attain profitable operations and generate funds there from and/or raise equity capital or borrowings sufficient to meet current and future obligations. These factors indicate the existence of a material uncertainty that may cast significant doubt about the Company's ability to continue as a going concern. Management intends to finance operating costs over the next twelve months with cash in hand, loans from directors and companies controlled by directors and or private placement of common shares. Should the Company be unable to continue as a going concern, the net realizable value of its assets may be materially less than the amounts on its statement of financial position.

2. Significant accounting policies

(a) Basis of preparation and statement of compliance

The condensed interim financial statements of the Company have been prepared in accordance with International Financial Reporting Standards ("IFRS") as issued by the international Accounting Standards Board ("IASB"), and comply with IAS 34. The condensed interim financial statements have been prepared on a historical cost basis and are presented in Canadian dollars, which is the Company's functional currency. This condensed interim financial report does not include all of the information required of a full audited annual financial report and it is therefore recommended that this report be reading conjunction with the annual financial statements of the Company for the year ended December 31, 2015. The accounting policies as reported in Note 2 of the audited annual financial statements for the year ended December 31, 2015 have been applied in preparing these condensed interim financial statements.

(b) Use of estimates and judgments

The preparation of the Company's condensed interim financial statements in conformity with IFRS requires management to make judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised and in any future periods affected.

(b) Use of estimates and judgments (continued)

The application of the Company's accounting policy for exploration and evaluation expenditures requires judgment in determining whether it is likely that future economic benefits are likely either from future exploitation or sale or where activities have not reached a stage which permits a reasonable assessment of the existence of reserves. The deferral policy requires management to make certain estimates and assumptions about future events or circumstances. Estimates and assumptions made may change if new information becomes available. If, after expenditure is capitalized, information becomes available suggesting that the recovery of expenditure is unlikely, the amount capitalized is written off in profit or loss in the period when the new information becomes available.

(c) Accounting standards issued but not yet effective

New standard IFRS 9 "Financial Instruments"

This new standard is a partial replacement of IAS 39 "Financial Instruments: Recognition and Measurement". IFRS 9 uses a single approach to determine whether a financial asset is measured at amortized cost or fair value, replacing the multiple rules in IAS 39. The approach in IFRS 9 is based on how an entity manages its financial instruments in the context of its business model and the contractual cash flow characteristics of the financial assets.

The new standard also requires a single impairment method to be used, replacing the multiple impairment methods in IAS 39. IFRS 9 is effective for annual periods beginning on or after January 1, 2018 with early adoption permitted. The adoption of IFRS 9 is not expected to have an impact on the Company's financial statements.

Other accounting standards or amendments to existing accounting standards that have been issued but have future effective dates are either not applicable or are not expected to have a significant impact on the Company's financial statements.

On September 16, 2011, the Company entered into an agreement with Eagle Plains Resources Ltd. ("Eagle Plains") whereby the Company was granted the sole and exclusive irrevocable right and option (the "Option") to acquire from Eagle Plains an undivided sixty (60%) percent interest in the Hall Lake Property, located in the Fort Steele Mining Division, British Columbia. The terms of the option agreement were amended on June 3, 2013, October 30, 2014 and November 13, 2015. The Company paid \$5,000 to Eagle Plains as an extension fee for November 13, 2015 amendment. The following information reflects the amended agreements.

The Option may be exercised by the Company:

(a) paying to Eagle Plains aggregate cash of \$600,000 as follows:

- (i) \$10,000 within 5 business days of the Company's shares being listed on the Exchange (the "Effective Date") (Paid);
- (ii) an additional \$75,000 on or before December 31, 2016;
- (iii) an additional \$100,000 on or before December 31, 2017;
- (iv) an additional \$150,000 on or before December 31, 2018; and
- (v) an additional \$265,000 on or before December 31, 2019.

- (b) issuing to Eagle Plains a total of 1,100,000 common shares of the Company, subject to such resale restrictions and legends as may be imposed by the applicable securities laws and the Exchange, as follows:
- (i) 100,000 shares within 10 business days of the Effective Date (Issued with a fair value of \$15,000);
 - (ii) 100,000 shares within 10 business days following TSX approval of the October 30, 2014 amendment (Issued with a fair value of \$7,000, Note 6);
 - (iii) an additional 200,000 shares on or before December 31, 2016;
 - (iv) an additional 200,000 shares on or before December 31, 2017;
 - (v) an additional 200,000 shares on or before December 31, 2018; and
 - (vi) an additional 300,000 shares on or before December 31, 2019.
- (c) incurring a total of \$3,000,000 in exploration expenditures on the Hall Lake Property ("Expenditures") as follows:
- (i) \$100,000 in Expenditures prior to December 31, 2011 (Incurred);
 - (ii) an additional \$200,000 in Expenditures prior to December 31, 2016;
 - (iii) an additional \$700,000 in Expenditures prior to December 31, 2017;
 - (iv) an additional \$1,000,000 in Expenditures prior to December 31, 2018; and
 - (v) an additional \$1,000,000 in Expenditures prior to December 31, 2019.

Should the Company give notice to Eagle Plains that it will terminate the option or surrender certain of the claims, the Company is obligated to keep the claims in good standing for a 24 month period from the date it provides notice.

At any time after June 1, 2016 and prior to exercise of the Option, Eagle Plains will have the right to terminate this agreement and Option by giving 30 days notice to the Company, and in such event the Company shall have no further obligations to Eagle Plains.

During the year ended December 31, 2015, the Company allowed certain claims to lapse which resulted in a \$109,690 impairment of evaluation and exploration assets.

6. Share capital

(a) Common shares

Authorized: unlimited common shares without par value.

Issued: At September 30, 2016 there were 8,400,000 issued and fully paid common shares (December 31, 2015 – 8,400,000).

During the year ended December 31, 2015, the Company issued 100,000 shares with a fair value of \$7,000 as option payment to the Hall Lake Property (Note 4).

(b) Stock options

On November 9, 2011, the Company adopted an incentive stock option plan, which provides that the Board of Directors of the Company may from time to time, at its discretion, and in accordance with the Exchange requirements, grant to directors, officers, key employees and consultants to the Company, options to purchase common shares, provided that the number of common shares reserved for issuance will not exceed 10% of the common shares issued and outstanding. Such options will be exercisable for a period of up to 10 years from the date of grant. In connection with the foregoing, the number of common shares reserved for issuance to any one optionee will not exceed five percent (5%) of the issued and outstanding common shares and the number of common shares reserved for issuance to all technical consultants will not exceed two percent (2%) of the issued and outstanding common shares. Options may be exercised no later than 90 days following cessation of the optionee's position with the Company or 30 days following cessation of an optionee conducting investor relations activities' position.

8. Financial instruments and risks

(a) Fair values

The fair values of receivables and accounts payable approximate their carrying values due to the short-term to maturities of these financial instruments.

(b) Interest rate risk

Interest rate risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company is not exposed to interest rate risk as it does not have any assets or liabilities that are affected by changes in interest rates.

(c) Credit risk

Credit risk is the risk that one party to a financial instrument will fail to discharge an obligation and cause the other party to incur a financial loss. The Company's primary exposure to credit risk is in its cash. The risk in cash is managed through the use of a major financial institution which has a high credit quality as determined by rating agencies. Credit risk is assessed as low.

(d) Foreign exchange rate risk

Foreign exchange risk is the risk that the Company's financial instruments will fluctuate in value as a result of movements in foreign exchange rates. The Company has no assets or liabilities denominated in foreign currencies; therefore, is not exposed to foreign exchange risk.

(e) Liquidity risk

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they become due. The Company requires funds to finance its business development activities. In addition, the Company needs to raise equity financing to carry out its exploration programs. There is no assurance that financing will be available or, if available, that such financings will be on terms acceptable to the Company. Liquidity risk is assessed as high.

(f) Price risk

The Company is exposed to price risk with respect to commodity prices. The Company's ability to raise capital to fund exploration and development activities is subject to risks associated with fluctuations in the market price of commodities.

9. Capital management

The Company's capital structure consists of cash and share capital. The Company manages its capital structure and makes adjustments to it, based on the funds available to the Company, in order to support acquisition and exploration of mineral properties. The Board of Directors does not establish quantitative return on capital criteria for management, but rather relies on the expertise of the Company's management to sustain future development of the business. The property in which the Company currently has an interest is in the exploration stage; as such, the Company is dependent on external financing to fund its activities. In order to carry out the planned exploration and pay for administrative costs, the Company will spend its existing working capital and raise additional amounts as needed. The Company will continue to assess new properties and seek to acquire interests in additional properties if it feels there is sufficient geologic or economic potential and if it has adequate financial resources to do so. Management reviews its capital management approach on an ongoing basis and believes that this approach, given the relative size of the Company, is reasonable. There were no changes in the Company's approach to capital management since inception. The Company is not subject to externally imposed capital requirements.
