

## Imagination Park to Produce the Mouse-X Feature Film Project

Vancouver, BC – June 28<sup>th</sup>, 2016 – Imagination Park Entertainment Inc. ("**Imagination Park**" or the "Company") is pleased to announce that it has entered into a partnership agreement with filmmaker Mr. Justin Tagg ("Mr. Tagg") to develop a full-length science fiction feature film. Mr. Tagg is the creator of an original treatment and short film entitled "Mouse-X," and has assigned all right, title, and interest in and to Mouse-X to the partnership.

Under the terms of the agreement, Imagination Park and Mr. Tagg will each have an equal and undivided interest in the project and all property created as a result. The agreement sets forth the parties' intention for Mr. Tagg to write a screenplay based on the short film, for Mr. Tagg to serve as Director, and for Imagination Park to act as the producer of the feature film.

For its part, Imagination Park will pay Mr. Tagg an undisclosed amount for entering into the agreement, and has equally agreed to spend an undisclosed amount to complete a feature script, concept art, and packaging for the Mouse X project.

CEO Gabriel Napora comments that "we are extremely excited to work with Justin, an incredibly talented filmmaker, to develop Mouse-X into a major feature film. I believe the Mouse-X proof of concept is exceptionally well done; the visual effects in the piece are mind blowing, along with the production design, and character development."

Director Yas Taalat adds "when I saw this short I knew it had to be made into a feature film, and look forward to advancing this project with some of our major Hollywood Studio partners."

Mouse-X is a mystery/sci-fi story about Anderson, a man who wakes in a building with no idea where he is or how he got there, before slowly discovering that in each of the

rooms around him are a thousand clones of himself, all of whom woke into the same mysterious scenario. To escape, he needs to outwit his 'selves' whilst overcoming the realization that he is not the only Anderson.
