These include MMA Journalist Ariel Helwani, actor and UFC enthusiast Chuck Zito, actor Jonathon Tucker from the hit series *Kingdom*, and retired MMA fighter and legend Urijah "The California Kid" Faber. Bisping also makes his way to Shanghai, China during the series but you'll have to stay tuned for the 6th and final episode to discover why!
