

# IMU BIOMMUNE TECHNOLOGIES INC

**Vancouver, British Columbia, October 18, 2015 - BioMmune Technologies Inc. (the “Company”) (TSX.V:IMU)** announces that further to the Company’s press release dated September 30, 2015, the Company will grant to Envoy Strategic Partners a total of 100,000 stock options priced at \$0.35 with a term of one year.
