Pascal Announces Extension of Share Purchase Warrants

VANCOUVER, BRITISH COLUMBIA, November 3, 2017 - Pascal Biosciences Inc. (TSX.V: PAS) (the "Company"), a Vancouver-based biotechnology company, wishes to announce that it will make an application to extend the exercise date of the 1,333,332 share purchase warrants currently exercisable until November 18, 2017 (the "Warrants"). Subject to the approval of the TSXV, the exercise date of the Warrants will be extended to May 18, 2018. The Warrants were issued with an original term of 24 months in connection with the closing of a private placement financing as announced by the Company on October 11, 2015.

A total of 333,333 Warrants are held by Insiders of the Company. The extension of the expiry of the Warrants is exempt from the valuation and minority shareholder approval requirements of Multilateral Instrument 61-101 ("MI 61-101") by virtue of the exemptions contain in section 5.5(a) and 5.7(1) (a) of MI 61-101 in that the fair market value of the consideration for the securities of the Company issued to an insider does not exceed 25% of its market capitalization.

Upon receipt of approval from the Exchange, the expiry date of the Warrants will change from November 18, 2017 to May 18, 2018. All other terms of the Warrants will remain the same.
