

# PASCAL BIOSCIENCES CLOSES PRIVATE PLACEMENT

**VANCOUVER, BRITISH COLUMBIA, March 24, 2020** – Pascal Biosciences Inc. (TSX.V: PAS) ("**Pascal**") is pleased to announce that it has closed its private placement previously announced on March 10, 2020 and March 13, 2020. The Company has issued 3,793,548 units of Pascal (each a "**Unit**") at a price of C\$0.09 per Unit to SōRSE Technology Corporation (the "**Purchaser**"), for gross proceeds of US\$250,000 (the "**Private Placement**").

Each Unit consists of one common share of Pascal and one common share purchase warrant (each, a "**Warrant**"). Each Warrant will entitle the Purchaser to purchase one additional common share of Pascal at a price of C\$0.15 for 18 months following the date which is six months after the date hereof.

Pascal intends to use the proceeds of the Private Placement for working capital purposes. All securities issued pursuant to the Private Placement will be subject to a statutory four month hold period from the date hereof. While the TSX Venture Exchange (the "**TSXV**") has conditionally approved the Private Placement, the Private Placement remains subject to the TSXV's final approval.
