

**EARLY WARNING REPORT

Common shares of Gaia Grow Corp. (the “**Issuer**”), head office located at Suite 303, 750 West Pender Street, Vancouver, British Columbia.

This report is filed in respect of the transfer of common shares of the Issuer in connection with a private transaction conducted by Transcend Capital Inc. (“**Transcend**”).

**Item 2 – Identity of the Acquiror**

The acquiror is Transcend, head office located at Suite 303, 750 West Pender Street, Vancouver, British Columbia.

*2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.*

On September 9, 2019, Transcend transferred 2,636,500 common shares of the Issuer to a third-party in a private transaction.

Etienne Moshevich is a joint actor with Transcend in respect of the securities that are the subject of this report.

**Item 3 – Interest in Securities of the Reporting Issuer**

Transcend transferred ownership and control of a total of 2,636,500 common shares in the capital of the Issuer to certain third-parties in a private transaction. The transfer of the common shares represents approximately 1.32% of the Issuer’s current issued and outstanding common shares.

*3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report.*

The transfer by Transcend of ownership and control of securities of the Issuer triggered the requirement to file this report.

Immediately prior to the deposition of securities of the Issuer, Transcend held 62,230,000 common shares of the Issuer, representing approximately 31.08% of the issued and outstanding common shares of the Issuer. Following completion of the disposition of securities of the Issuer, Transcend has ownership and control of 59,593,500 common shares of the Issuer, representing approximately 29.77% of the issued and outstanding common shares of the Issuer.

Transcend has ownership and control of 59,593,500 common shares of the Issuer, representing approximately 29.77% of the issued and outstanding common shares of the Issuer.

The securities were transferred at a price of \$0.08 per common share, for aggregate consideration of \$210,920.
