Each Unit consists of (i) one common share in the capital of the Issuer (each, a "Common Share"), and (ii) one half of a common share purchase warrant (each full warrant, a "Warrant"), with each full Warrant entitling the holder to subscribe for one additional Common Share at an exercise price of CAD \$0.12 per share at any time prior to the day that is 24 months from the grant of the Warrant

Following the Private Placement, the Acquiror owns or controls 14.2 % of the issued and outstanding Common Shares and 16.2 % assuming conversion or exercise of all securities owned or controlled by the Acquiror.
