MANAGEMENT'S DISCUSSION AND ANALYSIS

For the six months ended March 31, 2023

Management's Discussion and Analysis – March 31, 2023 As of May 17, 2023

The following management's discussion and analysis ("MD&A") of the financial condition and results of operations of Appia Rare Earths & Uranium Corp. ("Appia" or the "Company") constitutes management's review of the factors that affected the Company's financial and operating performance for the six months ended March 31, 2023. The MD&A was prepared as of May 17, 2023 and should be read in conjunction with the unaudited condensed interim financial statements for the three and six months ended March 31, 2023, the ("Financial Statements") and the audited financial statements for the year ended September 30, 2022, including the notes thereto. Unless otherwise stated, all amounts discussed herein are denominated in Canadian dollars. These Financial Statements of the Company have been prepared in accordance with International Financial Reporting Standards ("IFRS") as described in Note 2 to the Financial Statements.

Appia is a Canadian mineral exploration company listed on the Canadian Securities Exchange under the trading symbol "API", and in the USA the shares commenced trading on the OTCQX platform as "APAAF" on June 14, 2022. Graduating to the OTCQX marks an important milestone, demonstrating its qualifications and building visibility among U.S. investors. In Germany the shares trade under the symbols A0I.F, A0I.MU and A0I.BE. Appia is focused on the rare earth element ("REE") deposits at Alces Lake, particularly high priced "critical REE's", and on exploring high-grade, near-surface uranium deposits in the Athabasca Basin area.

ALCES LAKE HIGH-GRADE REE PROJECT

On July 26, 2022, Appia announced that the Company had completed the planned 2022 drilling / exploration program on the 100%-owned Alces Lake high-grade rare earth elements and gallium property, Athabasca Basin area, northern Saskatchewan.

In the 2022 drilling program, a total of 37 holes were drilled into WRCB to continue delineation of the high-grade REE mineralization and also delineate previously undrilled targets in Danny (adjacent to WRCB) as well as additional drilling into the Wilson/Wilson North zone. New WRCB drilling also extended the trend of the REE mineralization by approximately 120 metres along strike to a total of 280 metres of strike-length mineralization. The WRCB accumulation remains open in both the northwest and southeast directions.

The most significant new drilling area in 2022 was at Magnet Ridge, located approximately 1.5 kilometres south-southeast of WRCB on a well defined regional geologic corridor. A total of 34 holes (5,318 metres) were drilled into the primary Magnet Ridge target that outcrops on surface. A nearby (and possibly geologically related) prospect on Magnet Ridge West saw another 10 holes (2,025.9 metres) drilled. The mineralization in the two prospects appears to be geologically similar to the 2021 discovery AM zone at WRCB, which also outcrops on surface. Highlights from the Magnet Ridge drilling program are listed as follows:

- Drilling intersected thick sequences of REES from surface to 85 metres depth.
- The mineralized intervals are similar to, and larger in size when compared to the AMP Zone at WRCB.
- Total rare earths oxide (TREO) assays of up to 0.65 wt.% (6500 ppm) TREO were returned, with thickness
 and grades increasing by >50% to the south-southeast; all within 85 metres of surface.
- 19.85m @ 0.317 wt.% TREO including 8.94m @ 0.467 wt.% TREO in hole 22-AUG-031
- 18.67m @ 0.245 wt.% TREO including 9.02m @ 0.344 wt.% TREO in hole 22-AUG-030
- 26.70m @ 0.246 wt.% TREO including 6.08m @ 0.305 wt.% TREO in hole 22-AUG-013
- 28.19m @ 0.190 wt.% TREO including 3.07m @ 0.506 wt.% TREO in hole 22-AUG-026
- Follow-up drilling is planned.

REE mineralization was intersected in 27 of 34 DDHs near surface over significant strike length and drilled lengths exceeding 28 metres.

ALCES LAKE SUMMARY

Appia's 2022 drilling program included drilling significantly deeper holes to determine continuity at depth and along the identified REE mineralization trends, as the Company works toward making a maiden resource estimate in accordance with NI 43-101 requirements.

The Alces Lake project encompasses some high grade and critical* REEs and gallium mineralization, hosted within a number of surface and near-surface monazite occurrences that remain open at depth and along strike.

* Critical rare earth elements are defined here as those that are in short-supply and high-demand for use in permanent magnets and modern electronic applications such as electric vehicles and wind turbines (i.e. neodymium (Nd), praseodymium (Pr), dysprosium (Dy) and terbium (Tb)).

The Alces Lake project is located in northern Saskatchewan, the same provincial jurisdiction that is developing a "first-of-its-kind" rare earth processing facility in Canada (currently under construction by the Saskatchewan Research Council, with the Monazite Processing Unit scheduled to become operational in 2023).

In February 2023, the Company announced the acquisition of additional new mineral claims in the Alces Lake area.

The Alces Lake claim block now totals 38,522.43 contiguous hectares (95,191 acres); located approximately 50 kilometres east of Uranium City. The claims were staked on the basis of similar geological and geophysical signatures to the Company's current Alces Lake property.

Appia also holds a total of 75,314.72 hectares (186,106.72 acres) of land on four uranium claim blocks (Loranger, North Wollaston, Eastside, and Otherside). Exploration plans for these properties will be announced once permits are in hand.

2023 Exploration Plans at Alces Lake

All geochemical assay results are in hand from the 2022 exploration program. The Company is currently preparing for the 2023 exploration season (details to come on Appia's website) with several desktop initiatives to enhance its geological understanding of mineralization and to improve the Company's workflows relating to the acquisition, handling, integration, and interpretation of geoscientific data. The current work has involved the engagement of professional consultants to optimize Appia's geoscientific databases and to conduct comprehensive 3-dimensional modeling of the WRCB and Magnet Ridge mineralized zones.

Encouraged by Appia's 2022's drilling results, the Company intends to reopen the Alces Lake camp in summer 2023 for another season of REE (monazite-hosted) exploration. For this upcoming field season, follow-up geological, geophysical, and geochemical surveys are planned along and across the highest-priority areas of a 20 to 25 km-long structural corridor extending SSE from the main mineralized zones at WRCB and immediate area. This will aid in delineation and mapping of REE mineralized (monazite-rich) pegmatites and associated glimmerites to establish new drill targets.

2023 Brazilian Ionic Clay Rare Earths Element Project

On March 7, 2023 the Company announced that it had signed a Letter Agreement (the "Letter Agreement") with 3S LTDA ("3S") and Beko Invest Ltd. ("Beko") to acquire up to a 70% interest in the PCH Project (the "Transaction") located in the Tocantins Structural Province of the Brasília Fold Belt, Goiás State, Brazil (the "Target Property").

The Cachoeirinha Project (PCH Project) is located within the Tocantins Structural Province in the Brasília Fold Belt, more specifically, the Arenópolis Magmatic Arc. The PCH Project is 17,551.07 ha. in size and located within the Goiás State of Brazil. It is classified as an alkaline intrusive rock occurrence with highly anomalous REE and niobium mineralization. This mineralization is related to alkaline lithologies of the Fazenda Buriti Plutonic Complex and the hydrothermal and surface alteration products of this complex by supergene enrichment in a tropical climate. The positive results of the recent geochemical exploration work carried out to date indicates the potential for REE and Niobium within lateritic ionic adsorption clays.

Highlights:

- Appia is very pleased to have entered into the Letter Agreement to secure this high potential property in Brazil.
 The target is Heavy REEs enriched in ionic clays and should Appia be successful in delineating a substantial deposit, it would make Appia one of the few known critical REE companies in the world to have both light and heavy REE assets.
- A number of professional consultants with direct ionic clay REE deposit expertise have been contacted to bring together a project team suited for this specialized project.
- Appia will take until June 9, 2023 to complete its due diligence on the properties prior to finalizing this option agreement.

lonic adsorption REE clay deposits are the main source of the critical rare earth permanent magnet metals, dysprosium and terbium. Today China controls essentially all of the production of these metals, originally through the exploitation of its own domestic extensive fields of ionic clay REE deposits and through the control of the same deposit types in Myanmar. The production and use of dysprosium and terbium to modify rare earth permanent magnets so that they can withstand extreme temperature cycling without significant loss of magnetic strength is thus under Chinese control.

lonic clay REE deposits typically represent relatively simple metallurgy compared to other types of rare earth deposits; low associated radioactivity; minimal drilling, blasting and crushing operations in mining; and reduced tailings management requirements. The reduced mining, milling, processing and environmental considerations combined with high levels of the more valuable rare earth elements used in magnet applications can render even low grade ionic clay deposits attractive for development.

Letter Agreement Terms and Conditions

Appia has the option to earn a 60% interest in the Target Property by issuing an aggregate of 2.5 million common shares of Appia to Beko and spending US\$10 million on the Target Property over a period of five years. If Appia earns its 60% interest, it will then be obligated, within 90 days of earning its 60% interest, to issue a further US\$1,250,000 of common shares of Appia to Beko to earn a further 10% interest. Upon earning a 70% interest, Appia will grant to Beko a 1% net smelter returns royalty (the "1% NSR") in the Target Property. Appia will have a right of first refusal to acquire the 1% NSR. Thereafter, Appia and Beko will enter into a joint venture with respect to the further exploration and development of the Target Property (the "Joint Venture") with Appia holding a 70% interest and Beko holding a 30% interest in the Joint Venture. Upon the formation of the Joint Venture, Beko will have 90 days within which to elect to either (a) participate in the Joint Venture and contribute its pro rata share of expenditures or be diluted; (b) sell all of its 30% interest in the Joint Venture, subject to a right of first refusal in favour of Appia; or (c) elect to have Appia fund its pro rata share of expenditures pursuant to the Joint Venture subject to the right of Appia to be reimbursed for 150% of the expenditures made by Appia on behalf of Beko.

The Transaction is subject to satisfactory completion of a due diligence review of 3S, Beko and the Target Property by Appia. Appia will have 90 days to complete its due diligence review. The execution of the Letter Agreement will be followed by the good faith negotiation of formal documentation, including a definitive agreement (the "Definitive Agreement") between the parties, setting forth the detailed terms of the Transaction, including the terms set out in the Letter Agreement and such other terms and conditions as are customary for transactions of the nature and magnitude contemplated herein. All documentation shall be in form and content satisfactory to each party and their respective counsel. The final structure of the Transaction will be determined after each of Appia and 3S / Beko have

had the opportunity to consider all legal, tax and securities elements of the Transaction in order to ensure the most efficient structure for each of the parties and their respective security holders. It is anticipated that on the closing of the Transaction, to occur on or before June 9, 2023 (the "Closing"), the Target Property will be transferred by 3S to and held by a newly incorporated Brazilian company ("NewCo") with Appia holding a 70% interest in NewCo and Beko holding a 30% interest in NewCo subject to Appia earning its 70% interest as provided herein. The Joint Venture will be governed by the terms of a unanimous shareholders agreement between Appia and Beko which will govern the relationship of the parties to the Joint Venture.

Appia will acquire incremental vested interests in the Target Property upon completion of specific expenditure requirements pursuant to the terms of the Letter Agreement, provided Appia issues at least 1 million common shares to Beko and spends at least US\$1 million on the Target Property (at which time it will have earned a 10% legal and beneficial ownership interest in the Target Property), Appia can elect to cease funding the PCH Project and will have earned an interest in NewCo based upon the expenditures made to the date of the election (the "Earned Interest") and the interest of Beko in NewCo will be adjusted 3 to 100% minus the Earned Interest. The parties will then determine how they wish to proceed with their respective interests in NewCo.

The Transaction is subject to the fulfillment of certain conditions precedent as are customary for transactions of this nature including compliance with the rules of the Canadian Securities Exchange. If the Definitive Agreement has not been executed by the Closing Date, the terms of the Letter Agreement shall govern the rights of the parties.

On April 26, 2023 the Company announced that it had completed its onsite due diligence program at The Cachoeirinha Project (the "PCH Project") located in the Tocantins Structural Province of the Brasília Fold Belt, Goiás State, Brazil.

As part of the due diligence process, 15 auger holes were drilled twinning a representative mix of trenches, drill and auger holes across the western portion of the property which were sampled at ½ metre intervals, with assaying now underway. In addition, two diamond drill holes originally completed by the Vendor's team, but not previously assayed, were sampled and included as part of the total sample package delivered for assaying.

A total of 269 samples were taken and are now being processed at the SGS labs near Belo Horizonte, Brazil. Assay results are expected back late May 2023.

As previously reported, the PCH REE project minerology has very similar characteristics to the Serra Verde project demonstrating the classic model of ionic clay REE structures. Based on assays obtained from the vendor, REE grades appear to be similar to those reported at the Serra Verde project. Serra Verde Mining is a Brazilian company bringing its ionic clay REE deposit into production in northern Goias State, Brazil.

Like Serra Verde, Appia's PCH Project is an ionic-clay REEs deposit and one of the relatively few deposits of this type found outside of China. Ionic clays can be mined with low-cost open pit mining techniques and processed using simple technologies. The PCH Project is a classical, highly weathered alkaline granitic complex showing ionic clay development with elevated REE values immediately below surface and extending down to a depth of over 15 metres, and is located in close proximity to a very large ultra mafic complex currently being evaluated by its owner Vale S.A.

The PCH Project is 17,551.07 ha. in size and is a circular structure originating from significant depth and brings with it a series of REEs. Early indications are that the primary minerology is primarily bastnaestite and monazite with clays that are preferentially enriched in the valuable magnetic rare earth elements. Historic work by the Vendors indicates that the magnetic REEs praseodymium (Pr), neodymium (Nd), dysprosium (Dy) and terbium (Tb) represent +/- 25% of the total REEs found within the project area.

Uranium and Rare Earth Elements Outlook

REE - The trade war between the USA and China is jeopardizing the availability of critical REEs. The Company's Alces Lake project contains some of the highest-grade total critical REE mineralization in the world.

A shortage of critical REEs has developed, largely a result of the increase in electric vehicle production. China continues to control the pricing of REEs. Some of the REE concentrates is imported, processed in China to final form and re-exported.

Since the coup in Myanmar in February 2021, the Chinese are illegally mining across the border in areas controlled by a junta-sponsored militia. Myanmar is China's largest, rare earth source. In 2020 Myanmar accounted for 74% of Chinese imports of rare earths for refining, processing and sale around the world. Around ten rare earth mines have opened illegally across an uncontrolled border in Myanmar, with considerable environmental damage and pollution of the rivers.

For the supply of critical REEs required by the defence industry and for electronics, Washington is working on plans to reduce the dependence on China for the supply of critical REEs. There is a growing cooperation between Canada and USA in finding and producing REEs in North America, a long-term objective. A bipartisan bill was introduced in the American Senate which would force the US defence contractors to avoid use of China-sourced rare earth metals; it would also seek to create a strategic stockpile in the US.

Uranium - Cameco is reactivating the shut down McArthur River uranium mine over a period of time. Operations at Cigar Lake, the world's largest single uranium mine are increasing. Cameco is using its inventory of mined uranium and is expected to continue purchasing on the spot market this year in order to satisfy its contractual delivery requirements and reported an increase of only 41% in its average realized price over the same period in 2021 due to the impact of fixed price contracts.

The uranium demand forecast shows an increase from China, and in 2021 known supply sources were projected to be unable to match demand. Industry opinion is that long term contract prices of US\$60 per pound is needed before any new mining project advances. The spot price is currently around US\$48 per pound. The World Nuclear Association recently projected an annual production shortfall of 50 million pounds in the near future, but there is idle production capacity available at this time.

The political stability of countries supplying the US with uranium and REEs has caused concern in the United States, as it relies on imports of uranium for reactors and for the supply of REEs required by the defence industry, for electronics and high strength magnets needed in the electric vehicle and wind farm applications.

Ontario Properties

Appia holds over 13,008 hectares (32,143 acres) encompassing five mineralized zones in the Elliot Lake area of northern Ontario. The zones are called Teasdale, Banana Lake, Canuc, Bouck Lake and Buckles Lake. The Elliot Lake area produced some 360Mlbs. of U_3O_8 from 13 underground mines between 1955 and 1996 and is the only mining camp in Canada that had significant historical commercial REE production.

No work has been carried out in recent years, as the current market price for uranium oxide does not yet warrant additional work at this time.

The Company is considering the next stage of the Teasdale exploration and evaluation. The longer-term outlook for uranium prices is positive and the successful recovery of the REEs, particularly the critical elements of the total rare earths encountered, is very encouraging. Factors favourable for the project include the following:

- new mine infrastructure development would be in brownfield areas already disturbed by industrial and mining activity;
- water, electrical, transportation and communications infrastructure are in place or close at hand;
- the recovery of uranium from Elliot Lake ore is well known. Based on Teasdale Lake test results, the recovery of REEs appears to face no significant technical uncertainties;

- Appia is not responsible in any manner for potential future environmental impacts arising out of historical mining operations or waste disposal; and,
- The Cameco uranium refinery is located approximately 60 km away, near Blind River.

Results of Operations

The Company spent \$596,099 on deferred evaluation expenditures for the six months ended March 31, 2023 (2022 - \$4,368,216). The very large decrease reflects the extension of the 2021 drilling program to December 2021.

Total general and administrative expenses for the three months ended March 31, 2023, were \$777,006 compared to \$340,549 in 2022, higher due to an increase in non-cash share-based compensation to \$416,983 (2022 - \$114,644), an increase in investor relations to \$113,718 (2022 - \$61,928) and management fees and salaries to \$103,362 (2022 - 46,016).

Total general and administrative expenses for the six months ended March 31, 2023, were \$1,419,977 compared to \$668,636 in 2022, higher due to an increase in non-cash share-based compensation to \$790,806 (2022 - \$258,927), an increase in professional fees to \$136,104 (2022 - \$109,856), investor relations to \$199,224 (2022 - \$130,389) and management fees and salaries to \$171,525 (2022 - 90,557).

The Company's net loss and comprehensive loss for the three and six months ended March 31, 2023, was loss \$620,643 (2022 – income \$718,662) and loss of \$1,262,682 (2022 – income \$396,124).

Capital Resources and Liquidity

At March 31, 2023, the Company had working capital of \$6,004,249 (after providing \$76,655 owing to related parties) compared to a working capital of \$4,519,263 as at September 30, 2022 and had working capital of \$5,815,000 at May 17, 2023. In January 2022 the Company paid the accumulated related party amount owing to the Chief Executive Officer of \$570,375 and the accrued fees owing to the independent directors of \$80,500.

In November 2021, the Company closed non-brokered private placements with the sale of 2,222,222 FT Units at \$0.90 per FT Unit for gross proceeds of \$2,000,000 and 6,500,000 FT Units at \$1.00 per FT Unit for proceeds of \$6,500,000, for an aggregate \$8,500,000.

On November 22, 2022, the Company closed the first tranche of a non-brokered private placement of 5,000,000 flow-through shares at \$0.50 per share subject to a hold period expiring March 23, 2023.

On December 8, 2022, the Company closed the final tranche of the private placement with the issuance of 1,980,000 flow-through shares for gross proceeds of \$990,000 and working capital units ("WC units") at \$0.43 for gross proceeds of \$176,000. The WC units consist of one common share and one common share purchase warrant to acquire one common share at an exercise price of \$0.65 until December 8, 2023.

The Company has no operating revenue and has historically funded its operations with equity based private placements. The Company's future exploration plans are contingent on raising capital but has financial resources to fund its planned exploration program and administration costs for the next twelve months.

The Company's ability to meet its obligations and continue as a going concern is dependent on the ability to identify and complete future financings. While the Company has been successful in raising financings, there can be no assurance that it will be able to do so in the future.

The weighted average fair value of the options issued in the fiscal year 2022 was calculated as \$0.45 per share option. The fair value was estimated at the date of grant using the Black-Scholes pricing model with the following assumptions: risk-free weighted-average interest rate of 0.490-0.86% expected dividend yield of nil expected volatility of 126.72-180.31% and expected life term of 60 months. Options that have been issued generally vest one-half immediately on the date of grant and one-half twelve months from the date of grant.

The weighted average fair value of the options granted on October 18, 2022, was calculated as \$0.38 per share option. The fair value was estimated at the date of grant using the Black-Scholes pricing model with the following assumptions: risk-free weighted-average interest rate of 3.51% expected dividend yield of nil expected volatility of 120.61% and expected life term of 60 months. Options that have been issued generally vest immediately on the date of grant.

The weighted average fair value of the options granted on January 4, 2023, was calculated as \$0.22 per share option. The fair value was estimated at the date of grant using the Black-Scholes pricing model with the following assumptions: risk-free weighted-average interest rate of 3.28% expected dividend yield of nil expected volatility of 118.98% and expected life term of 60 months. Options that have been issued generally vest one-half immediately on the date of grant and one-half twelve months from the date of grant.

Warrants

On certain issuances of common shares, the units include warrants entitling the holder to acquire additional common shares of the Company, and the Company also grants warrants as consideration for services associated with the private placement of such issues.

The number of common shares outstanding on May 17, 2023 was 130,523,563. Taking into account outstanding share purchase options and warrants, the fully diluted number of common shares that could have been outstanding on May 17, 2023 was 153,831,937.

Related Party Transactions

During the three and six months ended March 31, 2023, the Company incurred related party expenses totaling \$135,137 (2022 – \$62,813) and \$199,900 (2022 - \$146,025). These expenses related to management fees paid or payable to key management personnel; Tom Drivas, Chief Executive Officer, Frederick Kozak, President from March 8, 2021 to August 31, 2022, Stephen Burega, President from January 4, 2021, Frank van de Water, Chief Financial Officer, and office administration services paid to Romios Gold Resources Inc., a company with a number of common directors and officers. The amount charged for office administration services is included under office and general expenses. At March 31, 2023, \$31,720 (2022 - \$16,478) of accumulated related party expenditures was payable to the other officers and Romios Gold Resources Inc.

One insider of the Company subscribed for 17,000 FT Units for \$15,300 in the November 2021 private placement.

In the 2022 fiscal year the Company paid the accumulated related party amounts owing to the Chief Executive Officer of \$570,375 and the accrued fees owing to the independent directors of \$80,500.

During the 2022 fiscal year, Directors exercised 1,915,000 share purchase options at the exercise price of \$0.30 per share and 350,000 share purchase options at the exercise price of \$0.25 per share.

Key management personnel were not paid post-retirement benefits, termination benefits, or other long-term benefits during the period ended March 31, 2023, and 2022.

During the three and six months ended March 31, 2023, the Company incurred expenses of \$5,500 (2022 - \$4,000) and \$11,000 (2022 - \$6,000) for independent directors' fees. At March 31, 2023, \$27,000 (2022 - \$6,000) of accrued directors' fees was outstanding.

During the three and six months ended March 31, 2023, the Company incurred expenses of \$21,140 (2022 - \$12,224) and \$66,277 (2022 - \$78,596) for legal fees to a law firm related to a director of the Company, William R. Johnstone. At March 31, 2023 \$17,935 (2022 – \$3,368) was payable to this related party.

On January 5, 2023, the Company granted 1,000,000 options to purchase common shares exercisable at \$0.35 per share for five years to the new President of the Company, Stephen Burega.

As disclosed in Note 5 to the financial statements, the Elliot Lake exploration properties were acquired from a related party that holds a 1% Uranium Production Payment Royalty and a 1% NSR Royalty on any precious or base metals payable provided that the price of uranium is greater than US\$130 per pound.

Carrying value of exploration and evaluation assets

The Company regularly reviews the carrying value of its properties to determine whether the cost of these assets will be recoverable from future cash flows or from the proceeds of their disposal. Assumptions underlying the cash flow estimates would include the forecasted prices for uranium and rare earth elements, planned production levels, and operating, capital, exploration and reclamation costs, which are all subject to risks and uncertainties. Management has determined that there is no impairment of the carrying value of its exploration properties.

Off-Balance Sheet Arrangements

The Company does not have any off-balance sheet arrangements.

Financial Instruments and risk management

The Company is required to disclose information about the fair value of its financial assets and liabilities. Fair value estimates are made at the balance sheet dates, based on relevant market information and information about the financial instrument. These estimates are subjective in nature and involve uncertainties in significant matters of judgment and therefore cannot be determined with precision. Changes in assumptions could significantly affect these estimates.

The Company's financial instruments recognized in the balance sheet consist of cash and cash equivalents, HST/GST receivable and current liabilities. The fair value of these financial instruments approximates their carrying value due to the short maturity or current market rate associated with these instruments.

Risk Factors

There are a number of risks that could affect Appia's business prospects. They include the speculative nature and the ability to finance the exploration and development of the Company's mineral properties, operating hazards, environmental and other government regulations, competition in the marketplace, markets for the Company's securities and the demand for uranium and rare earth elements. The Company's viability will depend on defining recoverable and economic resources and establishing positive comprehensive feasibility studies leading to production decisions. After completion of positive feasibility studies, the Company's success is dependent on maintaining the title and beneficial interest in the properties, obtaining the necessary governmental approvals and the successful financing, construction and operation of a facility to profitably extract the contained metals.

Financial Capability and Additional Financing

The Company had a cash position of \$6,455,000 and working capital of \$5,815,000 at May 17, 2023, has no source of operating income and has no assurance that additional funding will be available to it for further exploration and development of its projects. Although the Company has been successful in the past in financing its activities through the sale of equity securities, there can be no assurance that it will be able to obtain sufficient financing in the future to continue as a going concern.

Pandemic COVID-19 risk

The declaration by the World Health Organization that the COVID-19 infectious virus is a global pandemic delayed the start of the 2021 exploration program in the calendar year. Although Saskatchewan has not experienced the dire results in other Provinces, there are government-imposed restrictions on access to the properties and regulation of proposed activity. It is uncertain what restrictions may be applied in the summer of 2022.

To ensure safe work conditions are met for the workforce, the Company developed exploration guidelines that comply with the Saskatchewan Public Health Order and the specific Northern Saskatchewan Administration District Order, in order to maintain social distancing and help prevent the transmission of the COVID-19 infectious virus. <u>Land access</u> Under the modified Mining Act (Ontario), the Company is required to obtain permits to conduct exploration and evaluation activities on its Ontario properties. The Ontario Government is required to consult with the First Nations in order to reach agreement to permit activity in areas considered to have been historically inhabited.

Similar restrictions have been enacted in Saskatchewan, requiring the Company to obtain permission to occupy the camp at Alces Lake. Necessary Permits are in place.
