### **ZARA ANNOUNCES \$100,000 PRIVATE PLACEMENT**

Toronto, Ontario, August 1, 2013 - Zara Resources Inc. (CNSX: ZRI) ("Zara") is pleased to announce that it has agreed to a private placement of 833,333 Units in the capital of Zara at \$0.12 per unit for the aggregate subscription amount of \$100,000.
