On January 21, 2019, Chandaria converted 83,333 Series C Preferred Shares of the Issuer into 1,428,565 common shares of the Issuer (the “**Conversion**”).

1,428,565 common shares of the Issuer (the “**Shares**”) were issued to Chandaria on January 21, 2019. Chandaria’s securityholding percentage in the Shares was changed from 2.1% to approximately 12.4%.

Following the issuance of 1,428,565 Shares, Chandaria beneficially owns or otherwise exercises control or direction over 1,652,165 Shares (13.8% of the issued and outstanding Shares as of January 21, 2019).

3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report.

Chandaria acquired directly 1,428,565 Shares (13.8% of the issued and outstanding Shares as of January 21, 2019).
