On December 21<sup>st</sup>, 2020, Mr. Frei, an officer of the Corporation, acquired 2,250,000 Units (each, a "**Unit**") at \$0.08 per Unit from the private placement offering of the Corporation (the "**Securities Acquired**") through Comfortra GMBH (the "**Acquisition**"). Each Unit is consisted of one Share and 1 Warrant exercisable at \$0.15 per Share expiring December 21, 2022. Of the Securities Acquired, there are 2,250,000 Shares ("**Shares Acquired**") and 2,250,000 Warrants ("**Warrant Acquired**")

Warrants and Debenture.
