On December 21st, 2020, Mr. Cantore, a former insider of the Corporation, acquired 1,500,000 Units (each, a “Unit”) at \$0.08 per Unit from the private placement offering of the Corporation (the “Securities Acquired”) (the “Acquisition”). Each Unit is consisted of one Share and 1 Warrant exercisable at \$0.15 per Share expiring December 21, 2022. Of the Securities Acquired, there are 1,500,000 Shares (“Shares Acquired”) and 1,500,000 Warrants (“Warrant Acquired”)

Item 3 – Interest in Securities of the Reporting Issuer

The Securities Acquired represent approximately 7.98% of the issued and outstanding shares of the Corporation on non-diluted basis and 14.78% on partially-diluted basis. Prior to the date of the Acquisition, Mr. Cantore held 340,000 shares and 10% convertible debenture in the principal amount of \$20,000 (the “Debenture”) that entitled to be convertible into 50,000 Shares of the Corporation assuming the exercise of the Debenture and excluding the interests of the Debenture (the “Debenture Shares”).

Immediate after giving effect to the Acquisition, Mr. Cantore owns or controls, directly or indirectly, 1,840,000

Shares, 1,500,000 warrants and 10% convertible debenture in the principal amount of \$20,000 that entitled to be convertible into 50,000 Debenture Shares, representing approximately 7.98% of the outstanding shares of the Corporation and 16.66% of the outstanding shares on a partially diluted basis, assuming exercises of the Warrants and Debenture.

Mr. Cantore currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Cantore may develop such plans or intentions in the future.
