The Corporation entered into a Share Purchase Agreement pursuant to which the Corporation acquired all of the issued and outstanding shares of Targets Minerals Inc. on July 27, 2021 (the “Targets Acquisition”). Pursuant to the Targets Acquisition, Mr. Frei, an officer of the Corporation, received 12,075,454 shares (the “Securities Received”) in the share capital of the Corporation (each, a “Share”) at deemed price of \$0.20 as consideration (the “Transaction”). Of the Securities Received, 10,575,453 are held by Comfortra GmbH, an entity owned or controlled by Mr. Frei.

The Securities Acquired represent approximately 16.47% of the issued and outstanding shares of the Corporation on non-diluted basis. Prior to the date of the Transaction, Mr. Frei held, directly and indirectly, 4,688,500 Shares of the Corporation and 3,250,000 warrants.

Corporation and 26.14% of the outstanding shares on a partially diluted basis, assuming exercises of the Warrants.
