Mr. Leblanc disposed of an aggregate number of 1,631,629 Shares via public market, of these disposed Shares, 1,103,000 Shares were disposed on August 22, 2022, 211,629 Shares were disposed on August 23, 2022, 300,000 were disposed on August 25, 2022 and 17,000 were disposed on August 26 (collectively, the "**Disposition**").
