

NOTICE OF CHANGE IN CORPORATE STRUCTURE

National Instrument 51-102 – Section 4.9

Item 1 Names of the parties to the transaction

Auxellence Health Corporation (“**Auxellence**” formerly 0924888 B.C. Ltd.)
0961896 B.C. Ltd. (“**BC0961896**”)
C&C Cosmeceuticals Corporation (“**C&C**”)

Item 2 Description of the transaction

On June 19, 2013, Auxellence Health Corporation (“**Auxellence**” formerly 0924888 B.C. Ltd. or the “**Company**”), and its wholly owned subsidiary, 0961896 B.C. Ltd. (“**BC0961896**”), completed a three-cornered amalgamation (the “**Transaction**”) pursuant to the terms of an amalgamation agreement dated May 21, 2013, whereby BC0961896 and C&C Cosmeceuticals Corporation (“**C&C**”) amalgamated to create a new private company (“**Amalgamated C&C**”), which continued to be a wholly owned subsidiary of Auxellence and the former shareholders of C&C received common shares of Auxellence. The Transaction was approved unanimously by the shareholders of C&C by written consent resolution and Auxellence issued 39,825,000 common shares of Auxellence to the former shareholders holding common shares of C&C on a 1.25 for 1 basis. After the Transaction, the former shareholders of C&C became owners of more than 50% of the issued and outstanding share capital of Auxellence. Accordingly, the Transaction is a reverse takeover transaction and a restructuring transaction as defined in NI 51-102.

In addition, on May 29, 2013, 0924888 BC Ltd. completed a name change to Auxellence Health Corporation to better reflect the business of the Company.

Item 4 Names of each party, if any, that ceased to be a reporting issuer subsequent to the transaction and name of the continuing entities

C&C and BC0961896 were both private companies and after the amalgamation, Amalgamated C&C will remain a private company. Auxellence will continue to be a reporting issuer in British Columbia, Alberta and Ontario.

Item 5 The date of the reporting issuer’s first financial year-end after the Transaction

Item 6 The periods, including the comparative periods, if any, of the interim and annual financial statements required to be filed for the reporting issuers’ first financial year after the Arrangement

Auxellence prepared an unaudited pro forma consolidated balance sheet as at July 31, 2011, which financial information was included in the information circular of Haltain dated November 17, 2011 and filed on SEDAR on November 22, 2011. As such, Auxellence is required to file interim financial statements for the periods ended January 31, 2012, April 30, 2012, July 31, 2012, and January 31, 2013, and annual financial statements for its first financial year ended October 31, 2012.

The Company (pre-Amalgamation) has filed its first Annual Audited Financial Statements for the year ended October 31, 2012 and interim financial statements for the Company for the periods, January 31, 2012, April 30, 2012, July 31, 2012, and January 31, 2013. The Company has also filed as part of the material documents in connection with the material change report dated July 11, 2013 the annual audited financial statements for C&C as of June 30, 2012 (the private company that merged with BC0961896, to become Amalgamated C&C as a wholly owned subsidiary of Auxellence). In addition the Company has filed the nine months interim financial statements of C&C for March 31, 2013 as part of the material documents in connection with the material change report.

Subsequently, the Company has filed its interim financial statements for April 30, 2013 and will file (post-Amalgamation) interim financial statements for July 31, 2013, followed by annual financial statements for the year ended October 31, 2013, with applicable comparative information.
