MANAGEMENT DISCUSSION AND ANALYSIS ("MD&A") AS OF JUNE 29, 2023 TO ACCOMPANY THE UNAUDITED CONDENSED CONSOLIDATED INTERIM FINANCIAL STATEMENTS OF GLOBAL HEALTH CLINICS LTD. (THE "COMPANY") FOR THE NINE MONTHS ENDED APRIL 30, 2023.

This MD&A is dated June 29, 2023.

The following MD&A should be read in conjunction with the unaudited condensed consolidated interim financial statements of the Company for the nine months ended April 30, 2023 and the audited consolidated financial statements of the Company for the year ended July 31, 2022, which were prepared in accordance with International Financial Reporting Standards ("IFRS") and the notes thereto. All financial amounts are stated in Canadian currency unless stated otherwise.

This MD&A contains certain forward-looking statements based on the best beliefs, and reasonable assumptions of the management of the Company. There are many risks and uncertainties attached to the medicinal marijuana industry. Given these risks and uncertainties, the reader should not place undue reliance on these forward-looking statements. (See "Risks and Uncertainties" in this MD&A for more information).

DESCRIPTION OF THE BUSINESS

Overview

Global Health Clinics Ltd. (the "Company") was incorporated on March 18, 2013 in the Province of British Columbia. On August 24, 2018, the Company changed its name to Global Health Clinics Ltd. The Company commenced trading on the Canadian Securities Exchange under the symbol MJRX on August 29, 2018. The head office of the Company is located at 837 West Hastings Street, Suite 400, Vancouver, BC, Canada, V6C 3N6.

The Company engages in the cannabis industry and operates medical clinics which guide patients through the process of becoming legal users of marijuana. Through one of its subsidiaries, the Company also engages in developing psilocybin products for research and their potential usage for pharmaceutical purposes.

Since 2018, the Company closed acquisitions of Green Life Clinics Ltd. ("GLC") which holds all of the issued and outstanding securities of Patient Access Pavilions Ltd. ("PAP") and MCRCI Medicinal Cannabis Resource Centre Inc. ("MCRCI").

On May 5, 2020, the Company acquired all of the issued and outstanding shares of Anytime Health Corp. ("AHC"), a private British Columbia corporation. The acquisition was an arm's length transaction and did not constitute a fundamental change for the Company, nor did it result in a change of control of the Company.

On November 18, 2020, the Company acquired all of the issued and outstanding shares of 2770914 Ontario Inc. ("H2H"), a private Ontario corporation. The acquisition was an arm's length transaction and did not result in a change of control of the Company.

On January 20, 2021, the Company acquired all of the issued and outstanding shares of 2756407 Ontario Ltd. (Wonder), a private Ontario corporation. The acquisition was an arm's length transaction and did not result in a change of control of the Company.

On October 6, 2021, the Company closed a non-brokered private placement of 750,000 at a price of \$1.00 per unit for gross proceeds of \$750,000.

On November 9, 2021, the Company signed a memorandum of understanding with Cultivarium. The partnership would allow Wonder to research and develop psilocybin products to become a supplier of clean-start psilocybe genetics for psychedelics research and novel drug development sectors. Cultivarium is focused on developing new products to supply clinical trials, regulated markets and resellers, as well as creating custom active pharmaceutical formulations and contract manufacturer quality agreements. During the year ended July 31, 2022, the Company did not proceed with the Cultivarium partnership.

As of the date of this report, the Company focuses its business in virtual clinic by looking into expanding its telemedicine service beyond cannabis and into everyday health concerns. The Company has begun investigating potential targets for acquisition in Canada and the United States. Following the COVID-19 outbreak there has been a rapid adoption of telemedicine services for physicians and patients. The idea of telemedicine with centralized hub with synchronous and asynchronous telehealth services will be able to provide rural and tribal communities with adequate and improved healthcare in combination with clinics, hospitals and pharmacies. Specifically, the Company is exploring avenues in the lucrative niche telemedicine markets including dermatology, behavioral health, and correctional healthcare. Teledermatology is a growing area because it uses a "store and forward" system where images are transmitted to dermatologists, who may be in another state or province. They send their diagnosis to the referring physician or the patient. But dermatologists can also interact with patients in video exchanges. Behavioral health telemedicine lends itself to psychology in some ways because it focuses on a conversation between a therapist or physician and a patient. Correctional healthcare is for privately managed prisons looking to cut costs by looking at telemedicine. These are a few of the potential services the company will be looking to potentially expand into.

The Company is also open to opportunities in the cannabis and psilocybin space.

Corporate History

On August 24, 2018, the Company acquired all of the issued and outstanding securities of GLC which holds all of the issued and outstanding securities of PAP and MCRCI.

On July 26, 2019, the Company begun implementation of AdvancedCare. AdvancedCare is a software system which will enable the Company to make patient booking and tracking a more efficient and streamlined approach. By implementing AdvancedCare, the Company will be able to reduce staffing costs as the need for booking agents and support staff will be reduced significantly. The patient aftercare and doctor interaction will continue to be of utmost importance in order to maintain the reputation and standard of support given to current and onboarding patients.

During the year ended July 31, 2019, the Company completed a letter of intent with Integrative Alternative Health Services ("IAHS") to purchase all the property and assets of IAHS for \$15,000 cash and 8,000 common shares. The Company paid the cash consideration of \$15,000 during the year ended July 31, 2019,

which was recorded as a deposit. The Company did not intend to complete the acquisition, therefore, a loss on deposit of \$15,000 was recorded during the year ended July 31, 2021.

On May 5, 2020, the Company closed and acquired all of the issued and outstanding shares of Anytime Health Corp., a private British Columbia corporation.

On May 22, 2020, the Company consolidated its issued and outstanding share capital on the basis of up to one post-consolidation share for each ten pre-consolidation common shares.

On November 18, 2020, the Company acquired all of the issued and outstanding shares of 2770914 Ontario Inc. (H2H), a private Ontario corporation.

On January 20, 2021, the Company acquired all of the issued and outstanding shares of 2756407 Ontario Ltd. (Wonder Scientific), a private Ontario corporation.

On July 7, 2022, the Company consolidated its issued and outstanding common shares on the basis of one post-consolidated common share for every 20 pre-consolidated share.

As at April 30, 2023, MCRCI currently operates a virtual clinic in British Columbia via affiliate agreements with doctors.

Acquisition of Anytime Health Corp.

On May 5, 2020, the Company acquired all of the issued and outstanding shares of Anytime Health Corp. ("AHC"), a private British Columbia corporation. The Company issued 150,000 common shares of the Company to AHC shareholders (the "Transaction") with a fair value of \$215,950. AHC possesses a developmental stage web-based application to assist the Company with medical records and scheduling of daily appointments for medical clinics and medical offices. The parties agreed that an aggregate of 75,000 shares ("the Performance Shares") shall be issued to AHC shareholders upon the delivery, to the satisfaction of the Company in its sole discretion, of the Encryption Enhancement to the application (the "Performance Share Condition"). These shares were issued at \$2.80 per share on September 8, 2020 with a fair value of \$210,000.

The Transaction was accounted for as an acquisition of assets by way of share-based payment under IFRS 2 Share-Based Payment. The fair value of the total consideration has been allocated as below:

The web-based application was expected to improve and enhance the Company's scheduling at Medicinal Cannabis Resource Centre Inc. (the "MCRCI Clinics")—a virtual clinic.

Due to COVID, the MCRI clinics no longer required a scheduling application, and management decided not to pursue the further development of the web-based scheduling application, and impaired the AHC intangible asset. At July 31, 2021, the Company wrote down the value of the web-based application to \$Nil and recorded an impairment loss of \$298,845 (2020 - \$Nil) and are included in the consolidated statement of loss and comprehensive loss during the year ended July 31, 2021.

Acquisition of H2H

On November 18, 2020, the Company acquired all of the issued and outstanding shares of H2H. H2H owns Heart2Heart, a development-stage application that assists with connecting and locating medical professionals in the areas of mental health. Users of Heart2Heart will also have the ability to connect with fellow users to discuss and build a community around mental health awareness.

The Company issued an aggregate of 600,000 of its common shares to the shareholders of H2H in exchange for 100% of the issued shares of H2H. Pursuant to the share purchase agreement, the Company also issued 60,000 common shares to an entity that assisted with facilitating the transaction.

The transaction was accounted for as an acquisition of assets by way of share-based payment under IFRS 2 *Share-Based Payment*. The fair value of the total consideration has been allocated as below:

During the year ended July 31, 2021, the Company determined the fair value of the asset was \$Nil since the Company did not intend to further develop or use the asset. and therefore wrote down the value of the intellectual property to \$Nil and recorded an impairment loss of \$2,210,866.

The Company intended to use the H2H application to connect individuals seeking alternative mental health resources with researchers and health professionals in the alternative medicine space. The company anticipated using this application in connection with the nascent psilocybin research industry. The Company later acquired Wonder Scientific to advance its psilocybin strategy. Unfortunately, the Company struggled to integrate Wonder Scientific into its operations, and as a result of these difficulties, management decided not to pursue the further development of the H2H application and therefore impaired the H2H intangible assets.

Acquisition of Wonder

On January 20, 2021, the Company closed and acquired all of the issued and outstanding shares of Wonder. Wonder is a development-stage plant medicine company focused on the mental health and natural health and wellness marketplace.

The Company issued an aggregate of 1,300,000 of its common shares to the shareholders of Wonder in exchange for 100% of the issued shares of Wonder.

The consideration shares are subject to a voluntary pooling arrangement and (a) 198,957 of the consideration shares are subject to a 12-month pooling arrangement, whereby 50% of such shares will be released six months from the closing of the transaction and the remaining 50% of such shares will be released six months after that; and (b) 1,101,043 of the consideration shares will be subject to a four-month-and-one-day pooling arrangement, whereby 33% of such shares will be released on closing, 33% will be released two months after closing and the remaining 34% will be released four months and one day after closing. Pursuant to the share purchase agreement, the Company has also issued 105,000 common shares to various parties' who assisted with the transaction.

The transaction was accounted for as an acquisition of assets by way of share-based payment under IFRS 2 *Share-Based Payment*. The fair value of the total consideration has been allocated as below:

Due to operational and staffing difficulties, the Company is pausing all operations related to psilocybin and research into psychedelics and novel drug development. The Company will continue to pursue opportunities as they arise.

Educational Support Agreement with a Licensed Producer

The Company's subsidiary, Medicinal Cannabis Resource Centre Inc. (MCRC), entered into an agreement with Tilray Canada Ltd. (Tilray) on January 1, 2018 (the Tilray Agreement). Pursuant to the Tilray Agreement, MCRCI agreed to provide educational support to potential clients of Tilray in return for Tilray providing a rebate to MCRCI. The rebate is calculated on an individual-client basis by taking a percent of the gross revenue attributable to the products purchased from Tilray by a client that MCRCI provided education support and registered for Tilray's program. The Tilray Agreement provides for cooperation between MCRCI and Tilray, but does not require the unanimous consent of MCRCI and Tilray for actions taken in furtherance of the Tilray Agreement and does not prevent either party from making unilateral decisions. Pursuant to the Tilray Agreement, MCRCI may provide educational information regarding Tilray products to potential clients. However, Tilray has no control over the potential clients' selection made by MCRCI. Tilray is responsible for the acceptance, opening, and serving of the potential clients in regard to purchasing cannabis products. MCRCI has no control over Tilray's decision on accepting said potential clients. Both MCRCI and Tilray have no control over whether the potential clients make the

purchase of products by Tilray after educational support is provided by MCRCI and after Tilray accepts the client.

The Company and Tilray worked together in adding patients under the Access to Cannabis for Medical Purposes Regulations system.

Tilray, which is located on Vancouver Island, provided dedicated staff members not just throughout British Columbia but nationally to educate and support the staff of the Company when talking to patients and issuing ACMPR licenses during business hours. Further Tilray would give the Company patients priority processing/on-boarding, allowing them to order instantaneously, significantly decreasing patient processing/ordering time.

In May 2021, Tilray Inc merged with Aphria Inc.

During the nine months ended April 30, 2023, the Company recognized \$28,068 (2022 - \$43,700) income from the education fees derived from the agreements with other licensed producers which was included in the total sales during the nine months ended April 30, 2023.

Management Changes

On October 26, 2020, the Company appointed Andrew Parks to the board of directors. The Company also announced the resignation of Amin Lahijani as a director.

On January 20, 2022, the Company appointed Amin Lahijani to the board of directors. The Company also announced the resignation of Andrew Parks as a director.

The current composition of the Company's board of directors is as follows: Jatinder Dhaliwal, Usama Chaudhry, Judy Su, and Amin Lahijani.

Corporate Governance

The Board facilitates its exercise of independent supervision over the Corporation's management through frequent discussions with management and regular meetings of the Board.

Management is responsible for the preparation and integrity of the consolidated financial statements, including the maintenance of appropriate information systems, procedures and internal controls and to ensure that information used internally or disclosed externally, including the consolidated financial statements and MD&A, is complete and reliable. The Company's Board of Directors follows recommended corporate governance guidelines for public companies to ensure transparency and accountability to shareholders.

While the Company does not have formal orientation and training programs, new directors are provided with access to publicly filed documents of the Company, technical reports, internal financial information, and management and technical experts and consultants.

FINANCIAL STATEMENTS GOING CONCERN ASSUMPTION

The condensed consolidated interim financial statements have been prepared on the basis of accounting principles applicable to a going concern under IFRS. The use of these principles under IFRS assumes that the Company will continue in operation for the foreseeable future and will be able to realize assets and discharge its liabilities in the normal course of operations.

The Company's operations to date have been financed by issuing common shares and debt instruments. The Company's ability to continue as a going concern is dependent upon its ability to commence profitable operations, generate funds therefrom and raise additional financing in order to meet current and future obligations. The current cash position on hand and expected cash flows for the next 12 months are not sufficient to fund the Company's ongoing operational needs. Therefore, the Company will need funding through equity or debt financing, joint venture arrangements or a combination thereof. There is no assurance that additional funding or suitable joint venture arrangements will be available on a timely basis or on terms acceptable to the Company.

During the nine months ended April 30, 2023, the Company recorded net loss of \$1,324,885 (2022 - \$1,107,239). As at April 30, 2023, the Company had a working capital deficit of \$1,598,434 (July 31, 2022 - \$527,263) and had an accumulated deficit of \$35,058,942 (July 31, 2022 - \$33,734,057). The Company is actively seeking additional sources of financing. In assessing whether the going concern assumption is appropriate, management takes into account all available information about the future, which is at least, but not limited to, twelve months from the end of the reporting period. Management is aware, in making its assessment, of uncertainties related to events or conditions that may cast significant doubt upon the entity's ability to continue as a going concern. These uncertainties constitute a material uncertainty that casts significant doubt about the Company's ability to realize its assets and discharge its liabilities in the normal course of business. Accordingly, the condensed consolidated interim financial statements do not give effect to adjustments that would be necessary should the Company be unable to continue as a going concern and therefore realize its assets and discharge its liabilities and commitments in other than the normal course of business and at amounts different from those in the accompanying condensed consolidated interim financial statements. These adjustments could be material.

RESULTS OF OPERATIONS

For the three months ended April 30, 2023, the Company incurred a net and comprehensive loss of \$480,462 (2022 - \$242,922); (\$0.05) (2022 - \$0.06) loss per share. The Company earned revenues of \$23,539 (2022 - \$34,697) and incurred cost of sales of \$5,840 (2022 - \$10,630). The decrease in revenue was due to the decrease in membership sales during the current period. The increase in the Company's net loss is mainly comprised of increase in advertising and promotion of \$193,251 (2022 - \$Nil) due to increased promotional activities during the current period, higher bank charges, interest and accretion of \$15,945 (2022 - \$4,333) which includes loan interests, increase in salaries and wages of \$77,435 (2022 - \$51,324) which was due to increase in salaries paid to employees, higher legal and professional fees of \$26,554 (2022 - \$17,821),and higher management and director fees of \$62,000 (2022 - \$54,000) due to higher fees paid to directors during the current period. Those increases were offset by decrease in consulting and referral fees of \$65,560 (2022 - \$79,541) which was mainly due to lesser consulting services were incurred by the Company during the current period as compared to the comparative period, and decrease

in transfer agent fees of \$1,355 (2022-\$2,128) due to the decrease in transfer agent maintenance fees in the current period.

For the nine months ended April 30, 2023, the Company incurred a net and comprehensive loss of \$1,324,885 (2022 - \$1,107,239); (\$0.14) (2022 - \$0.30) loss per share. The Company earned revenues of \$80,053 (2022 - \$108,210) and incurred cost of sales of \$16,765 (2022 - \$24,631). The decrease in revenue was due to the decrease in membership sales during the current period. The decrease in cost of sales was due to the decrease in doctor fees incurred during the current period. The increase in the Company's net loss is mainly comprised of increase in advertising and promotion of \$593,171 (2022 - \$442,117) due to increased promotional activities during the current period, higher bank charges, interest and accretion of \$36,924 (2022 - \$8,377) which includes loan interests, higher legal and professional fees \$30,066 (2022-\$25,433), and increase in salaries and wages of \$198,767 (2022 - \$122,625) which was due to increase in salaries paid to employees. Those increases were offset by lower depreciation of \$366 (2022 - \$486), lower consulting and referral fees \$200,156 (2022 - \$293,334), lower filing and listing fee \$9,729 (2022 - \$13,552), lower management fees \$170,000 (2022 - \$184,391) due to lower management fees incurred during the current period, lower office and general expenses \$148,490 (2022 - \$179,244) as a result of lower corporate activities during the current period, and decrease in transfer agent fees of \$3,257 (2022 - \$5,130) due to the decrease in transfer agent maintenance fees in the current period,

For the nine months ended April 30, 2023, the net cash used in operating activities was \$873,670 (2022 - \$1,366,701), net cash provided by financing activity of \$436,000 (2022 - \$919,272), and net decrease in cash of \$437,670 (2022 - \$447,429). There were no cash provided by investing activity during the nine months ended April 30, 2023 and 2022. Depending on future events, the rate of expenditures and general and administrative costs could increase or decrease.

For the three months ended July 31, 2022, the Company incurred a net and comprehensive loss of \$261,949 (2021 - \$7,078,834); (\$0.03) (2021 - \$2.30) loss per share. The Company earned revenues of \$38,602 (2021 - \$44,041) and incurred cost of sales of \$6,185 (2021 - \$9,640). The decrease in revenue was due to the decrease in membership sales during the current period. The decrease in cost of sales was due to the decrease on doctor fees incurred during the current period. The decrease in the Company's net loss is mainly comprised of decrease in amortization of \$Nil (2021 - \$35,496) due to no impairment of intangibles

during the current year, lower depreciation of \$162 (2021 - \$222), lower consulting and referral fees of \$68,120 (2021 - \$239,678) which was mainly due to lesser consulting services used by the Company during the current period as compared to the prior period wherein higher consulting fees were incurred in relation to the business acquisitions, lower legal and professional fees of \$38,625 (2021 - \$64,059) which was due to less legal services used by the Company compared to higher legal fees incurred in the prior period relating to the business acquisition activities, lower management fees of \$54,000 (2021 - \$66,000) due to lower fees paid to directors during the current period, lower office and general expenses of \$45,801 (2021 - \$57,285), lower research and development of \$Nil (2021 - \$24,500) for Wonder Scientific, lower filing and listing fees of \$2,250 (2021 - \$2,294) which consisted mainly to lower filing fees during the current period, loss of lawsuit of \$Nil (2021 - \$89,840), loss on deposit of \$Nil (2021 - \$15,000), share-based payment expense on acquisition of \$Nil (2021 - \$3,970,200), and impairment loss on intangible assets of \$Nil (2021 - \$2,509,711). Those decreases in expenses are offset by the higher bank charges, interest and accretion of \$8,316 (2021 - \$2,230) which includes loan interests, higher salaries and wages of \$63,148 (2021 - \$35,520) which was due to increase in salaries paid to employees, and higher transfer agent fees of \$13,944 (2021 - \$1,200) which due to the increase in transfer agent maintenance fees in the current period.

For the year ended July 31, 2022, the Company incurred a net and comprehensive loss of \$1,369,188 (2021) - \$8,478,860); (\$0.37) (2021 - \$4.02) loss per share. The Company earned revenues of \$146,812 (2021 -\$225,093) and incurred cost of sales of \$30,816 (2021 - \$47,347). The decrease in revenue was due to the decrease in membership sales during the current year. The decrease in cost of sales was due to the decrease on doctor fees incurred during the current year. The decrease in the Company's net loss is mainly comprised of lower amortization of \$Nil (2021 - \$127,105) due to no impairment of intangibles during the current year, lower depreciation of \$648 (2021 - \$888), lower legal and professional fees of \$64,058 (2021 -\$110,837) which was due to less legal services used by the Company compared to higher legal fees incurred in the prior year relating to the business acquisition activities, lower management fees of \$238,391 (2021 -\$274,000) due to lower fees paid to directors during the current year, lower office and general expenses of \$225,045 (2021 - \$254,749), lower research and development of \$12,500 (2021 - \$42,000) for Wonder Scientific, lower consulting and referral fees of \$361,454 (2021 - \$581,239) due to decreased consulting fees paid by the Company to contractors during the year, loss of lawsuit of \$Nil (2021 - \$89,840), loss on deposit of \$Nil (2021 - \$15,000), share-based payment expense on acquisition of \$Nil (2021 - \$4,526,777), impairment loss on intangible assets of \$Nil (2021 - \$2,509,711), and the expense recovery of \$100,000 (2021 - \$Nil) relating to the payment made to a vendor and expensed in the prior year which was recovered during the current year. Those decreases in expense are offset by the higher advertising and promotion of \$442,117 (2021 - \$Nil) which consisted of the recent promotional activities of the Company, higher salaries and wages of \$185,773 (2021 - \$93,399) due to increased salaries paid to employees, higher transfer agent fees of \$19,074 (2021 - \$12,092) due to higher share issuances and higher transfer agent services used during the current year, higher filing and listing fees of \$15,802 (2021 - \$15,084) due to higher filing fees paid during the current year, higher bank charges, interest and accretion of \$16,693 (2021 - \$8,468) which includes the interest on loans received during the year, bad debt expense of \$1,255 (2021 - \$Nil), interest income of \$Nil (2021 - \$4,583), and loss on debt settlement of \$2,374 (2021 - \$Nil).

Fiscal 2023

During the three months ended April 30, 2023, the Company reported a net loss of \$480,462 compared to \$235,960 net loss during the three months ended January 31, 2023. Higher net loss in the current period was mainly due to the increase in advertising and promotional costs incurred during the current period for marketing activities, as compared to the three months ended January 31, 2023.

During the three months ended January 31, 2023, the Company reported a net loss of \$235,960 compared to \$608,463 net loss during the three months ended October 31, 2022. Lower net loss in the current period was mainly due to the decrease in advertising and promotional costs incurred during the current period for marketing activities, as compared to the three months ended October 31, 2022.

During the three months ended October 31, 2022, the Company reported a net loss of \$608,463 compared to \$261,949 net loss during the three months ended July 31, 2022. Higher net loss in the current period was mainly due to the increase in higher costs of advertising and promotional activities incurred during the current period. Revenue in the current quarter was also lower compared to the previous quarter.

Fiscal 2022

During the three months ended July 31, 2022, the Company reported a net loss of \$261,949 compared to \$242,922 net loss during the three months ended April 30, 2022. Higher net loss in the current period was mainly due to the increase in operational expenses during the current period as compared to three months ended April 30, 2022.

During the three months ended April 30, 2022, the Company reported a net loss of \$242,922 compared to \$486,977 net loss during the three months ended January 31, 2022. Lower net loss in the current period was mainly due to the decrease in advertising and promotional, consulting and referral fees, filing and listing fees, management and director fees, office and general expenses, and research and development offset by the increase in legal and professional fees and transfer agent fees during the current period.

During the three months ended January 31, 2022, the Company reported a net loss of \$486,977 compared to \$377,340 net loss during the three months ended October 31, 2021. Lower net loss in the preceding quarter was mainly due to the expense recovery of \$100,000 received in the previous quarter. Revenue in the current quarter was also lower compared to the previous quarter due to decrease in memberships during the current quarter.

During the three months ended October 31, 2021, the Company reported a net loss of \$377,340 compared to \$7,078,834 net loss during the three months ended July 31, 2021. The significant decrease in net loss is mainly due to decrease in operational expenses during the current period, and the impairment of intangible assets and share-based expense on acquisition incurred in during the three months ended July 31, 2021.

Fiscal 2021

During the three months ended July 31, 2021, the Company reported a net loss of \$7,078,834 compared to \$368,099 net loss during the three months ended April 30, 2021. The significant increase in net loss is mainly due to impairment of intangible assets of \$1,313,845 and stock-based compensation of \$4,938,601 incurred during the current period. During the three months ended July 31, 2021, the Company wrote down the value web-based application and intellectual property since the Company did not intend to further develop or use the assets. The Company also incurred stock-based compensation expenses on acquisition of Wonder.

Liquidity and Solvency

As at April 30, 2023, the Company had a working capital deficiency of \$1,598,433 and \$527,263 as at July 31, 2022. The Company will need access to equity capital to pursue its business plan and there is no guarantee that equity may be available, and if available it may not be on terms that Management finds is in the interest of the Company.

During the nine months ended April 30, 2023, the Company received loans totaling \$436,000. These funds have been used by the Company for operations. The Company is actively seeking additional sources of financing.

During the nine months ended April 30, 2023, the net cash used in operating activities was \$873,670 (2022 - 1,366,701) comprising of a net loss of \$1,324,885 (2022 - \$1,107,239), amortization and depreciation of \$366 (2022 - \$486), accretion and accrued interest of \$33,884 (2022 - \$4,879), gain on loan modification of \$2,753 (2022 - \$Nil), bad debt expense of \$Nil (2022 - \$1,255), increase in accounts receivable of \$704 (2022 - \$2,558), decrease in GST recoverable of \$15,900 (2022 - \$272), decrease in prepaid expenses of \$21,650 (2022 - \$98,845), increase in accounts payable and accrued liabilities of \$393,461 (2022 - decrease of \$361,353), and decrease in deferred revenue of \$10,589 (2022 - \$1,288).

During the nine months ended April 30, 2023, net cash provided by financing activity was \$436,000 (2022 - \$919,272). The cash provided by financing activity during the nine months ended April 30, 2023 was attributable to proceeds from loan while the cash provided by financing activities for the nine months ended April 30, 2022 was attributable to proceeds from private placements and proceeds from loans.

There were no cash provided by investing activity during the nine months ended April 30, 2023 and 2022.

On October 6, 2021 the Company completed a non-brokered private placement of 750,000 units at a price of \$1.00 per unit for gross proceeds of \$750,000.

On July 28, 2022, the Company closed a non-brokered private placement of 5,555,557 at a price of \$0.09 per unit for gross proceeds of \$500,000.

During the year ended July 31, 2022, the Company received loans amounting to \$279,273 from a related party and from third parties. The loans bear interest of 10% per annum.

During the nine months ended April 30, 2023, the Company received loans amounting to \$436,000 from a related party and from third parties. The loans bear interest of 10% per annum.

The Company continues to use its cash resources to fund its operations. As the Company has limited sources of revenue to fund its ongoing operations and to settle its obligations, the Company may require additional funding through equity or debt financing, joint venture arrangements or a combination thereof to accomplish its long-term strategic objectives. There can be no assurance, however, that the Company will be successful in its efforts. If such funds are not available or other sources of financing cannot be obtained, then the Company will be forced to curtail its activities.

Capital Resources

The Company continues to use its cash resources to fund its operations. As the Company has limited sources of revenue to fund its ongoing operations and to settle its obligations, the Company may require additional funding through equity or debt financing, joint venture arrangements or a combination thereof to accomplish its long-term strategic objectives.

Cash Provided by Financing Activities

During the nine months ended April 30, 2023, cash generated from financing activities was \$436,000 (2022 - \$919,272). The cash flow from financing activities in the nine months ended April 30, 2023 was comprised of loans received.

The details are disclosed in Note 15 of the condensed consolidated interim financial statements for the nine months ended April 30, 2023.

Use of Proceeds

During the nine months ended April 30, 2023, the Company received loans of \$436,000. Proceeds from these loans were used for general working capital purposes.

Share Capital

The following is a summary of the Company's outstanding share, warrant and stock options data as of June 29, 2023.

On July 7, 2022, the Company consolidated its issued and outstanding common shares on the basis of one post-consolidated common share for every 20 pre-consolidated share. All shares figures have been retroactively adjusted to reflect share consolidation.

Common Shares

The authorized capital of the Company consists of an unlimited number of common shares without par value of which 9,392,138 are outstanding. Holders of the Company's common shares are entitled to vote at all meetings of shareholders declared by the directors, and subject to the rights of holders of any shares ranking in priority to or on a parity with the common shares, to participate rate-ably in any distribution of property or assets upon the liquidation, winding up or dissolution of the Company.

On October 6, 2021, the Company closed a non-brokered private placement of 750,000 at a price of \$1.00 per unit for gross proceeds of \$750,000. Each unit consists of one common share of the Company and one share purchase warrant entitling the holder to acquire an additional share at a price of \$0.055 per share for a period of 36 months following the date of issue. The fair value of the warrants was estimated to be \$372,828, which was determined using the Black-Scholes Option Pricing Model with the following assumptions: expected life -3 years; volatility -300.37%; risk-free interest rate -0.52%; dividend rate -0%.

On July 28, 2022, the Company closed a non-brokered private placement of 5,555,557 at a price of \$0.09 per unit for gross proceeds of \$500,000. Each unit consists of one common share of the Company and one

common share purchase warrant of the Company. Each full warrant is exercisable into a common share of the Company for a period of 24 months at an exercise price of \$0.12. The fair value of the warrants was estimated to be \$238,697, which was determined using the Black-Scholes Option Pricing Model with the following assumptions: expected life -2 years; volatility -231.56%; risk-free interest rate -2.94%; dividend rate -0%.

Preferred Shares

The authorized capital of the Company consists of an unlimited number of preferred shares without par value, of which 100 are issued or outstanding as of December 22, 2022. The preferred shares rank in priority to the common shares upon the liquidation, winding up or other dissolution of the Company. The preferred shares were issued in August 2013, as part of the plan of arrangement with Zara Resources Inc.

Escrow Shares

As of June 29, 2023, Nil common shares were held in escrow. Under the applicable escrow agreement, 323,955 were released during the year ended July 31, 2020, 215,970 were released during the year ended July 31, 2021, and 107,984 were released during the year ended July 31, 2022.

On July 28, 2022, the Company issued 5,555,557 common shares from private placement. The shares have a hold period of four months and one day.

Stock Options

There were no stock options granted during the nine months ended April 30, 2023 and year ended July 31, 2022.

As of June 29, 2023, no stock options are outstanding.

Warrants

As of June 29, 2023, the Company has 6,305,557 share purchase warrants outstanding.

Outlook and Capital Requirements

There is no guarantee that market conditions will be conducive to raising additional equity capital. Depending on future events, the rate of Company expenditures and general and administrative costs could increase or decrease.

Related Party Transactions

During the nine months ended April 30, 2023, the Company incurred management fees of \$135,000 (2022 - \$135,000) to Jatinder Dhaliwal, CEO and director of the Company, \$27,000 (2022 - \$27,000) to Usama Chaudhry, CFO and director of the Company, and director fees of \$8,000 (2022 - \$5,000) to Judy Su, director of the Company.

At April 30, 2023, the Company had a balance of \$50,400 (July 31, 2022 - \$22,050) due to Usama Chaudhry, and a balance of \$294,235 (July 31, 2022 - \$167,964) due to Jatinder Dhaliwal.

During the nine months ended April 30, 2023, the Company received loan of \$58,000 (year ended July 31, 2022 - \$83,159), from 1248787 BC Ltd., a company controlled by Jatinder Dhaliwal. The loans bear interest of 10% per annum. As of April 30, 2023, the loans had a balance of \$153,017 (July 31, 2022 - \$86,591),

including accrued interest of \$11,858. Interest expenses recorded for the nine months ended April 30, 2023 was \$8,426 (2022 - \$16).

Except for the loan payable, the amounts payable to related parties are unsecured, non-interest bearing and have no specific terms of repayment.

Contractual Obligations

There are no contractual obligations, aside from those disclosed in this MD&A that will materially affect the performance of the Company.

Off-Balance Sheet Arrangements

The Company does not utilize off-balance sheet transactions.

Proposed Transactions

There are no proposed transactions that will materially affect the performance of the Company other than those disclosed in this MD&A.

Accounting Policies

The accounting policies and methods employed by the Company determine how it reports its financial condition and results of operations, and may require management to make judgments or rely on assumptions about matters that are inherently uncertain. The Company's results of operations are reported using policies and methods in accordance with IFRS. In preparing financial statements in accordance with IFRS, management is required to make estimates and assumptions that affect the reported amounts of assets, liabilities, revenues and expenses for the period. Management reviews its estimates and assumptions on an ongoing basis using the most current information available. These condensed consolidated interim financial statements have been prepared by management in accordance with IFRS. Significant accounting policies used have been outlined on the condensed consolidated interim financial statements for the nine months ended April 30, 2023.

Significant Estimates and Judgments

The preparation of these condensed consolidated interim financial statements in accordance with IFRS requires management to make judgements and estimates and form assumptions that affect the reported amounts of assets and liabilities at the date of the consolidated financial statements and reported amounts of revenues and expenses during the reporting period. On an ongoing basis, management evaluates its judgments and estimates in relation to assets, liabilities, revenue and expenses.

Management uses historical experience and various other factors it believes to be reasonable under the given circumstances as the basis for its judgements and estimates. Actual outcomes may differ from these estimates.

The effect of a change in an accounting estimate is recognized prospectively by including it in comprehensive income/loss in the year of the change, if the change affects that year only, or in the year of the change and future years, if the change affects both.

Critical judgments in applying accounting policies

Information about critical judgments in applying accounting policies that have the most significant risk of causing material adjustment to the carrying amounts of assets and liabilities recognized in the condensed consolidated interim financial statements within the next financial year are discussed below:

Going concern risk assessment

The Company's ability to continue its operations and to realize assets at their carrying values is dependent upon its ability to commence profitable operations, generate funds therefrom and raise additional financing in order to meet current and future obligations. These condensed consolidated interim financial statements do not give effect to any adjustments required to realize its assets and discharge its liabilities in other than the normal course of business and at amounts different from those reflected in the accompanying condensed consolidated interim financial statements.

Impairment of non-financial assets

Judgment is involved in assessing whether there is any indication that an asset or cash-generating unit may be impaired. This assessment is made based on the analysis of, amongst other factors, changes in the market or business environment, events that have transpired that have impacted the asset or cash-generating unit, and information from internal reporting.

Key sources of estimation uncertainty

The following are key assumptions concerning the future and other key sources of estimation uncertainty that have a significant risk of resulting in material adjustments to the condensed consolidated interim financial statements.

Allowance for doubtful accounts

The Company must make an assessment of whether account receivables are collectible from debtors. Accordingly, management establishes an allowance for estimated losses arising from non-payment, taking into consideration customer credit, current economic trends and past experience. If future collections differ from estimates, future earnings would be affected.

Impairment

Assets, including property and equipment and intangible assets, are reviewed for impairment whenever events or changes in circumstances indicate that their carrying amounts may exceed their recoverable amounts.

Estimated useful lives of property and equipment and tangible assets

The Company makes estimates and utilizes assumptions in determining the useful lives of the property and equipment and intangible assets, and the related depreciation and amortization. Uncertainties in these estimates relate to technical obsolescence and the average life of a patient relationship that may change the utilization of certain assets.

Share-based payments

The Company records all share-based payments using the fair value method. The Company uses the Black-Scholes Option Pricing Model to determine the fair value of share-based payments. This estimate also requires determining the most appropriate inputs to the valuation model. The main factor affecting the estimates of the fair value of stock options is the stock price, expected volatility used and the expected

duration of the instrument. The Company currently estimates the expected volatility of its common shares based on comparable information derived from the trading history of guideline public companies which are in a similar situation to the Company taking into consideration the expected life of the options.

While management believes the estimates contained within the condensed consolidated interim financial statements are reasonable, actual results could differ from those estimates and could impact future results of operations and cash flows.

Capital Management

The Company manages its capital structure and makes adjustments to it, based on the funds available to the Company, in order to support its operation and to ensure it continues as a going concern. The Board of Directors does not establish quantitative return on capital criteria for management, but rather relies on the expertise of management to sustain future development of the business.

As at April 30, 2023, the Company's capital deficit amounted to its share capital, reserves and deficit of \$1,884,466 (July 31, 2022 - \$559,581).

The Company's capital management objectives, policies and processes have been directed towards the cannabis and psilocybin industries during the year ended July 31, 2022 and the period ended April 30, 2023. The Company is not subject to any externally imposed capital requirement. There were no changes in the Company's approach to capital management during the period.

Risks and Uncertainties

The following are certain factors relating to the business of the Company, which factors investors should carefully consider when making an investment decision concerning the shares of the Company. The Company will face a number of challenges in the development of its business. These risks and uncertainties are not the only ones facing the Company. Additional risks and uncertainties not presently known to the Company or which are currently deemed immaterial, may also impair the operations of the Company. If any such risks actually occur, shareholders could lose all or part of their investment and the financial condition, liquidity and results of operations of the Company could be materially adversely affected and the ability of the Company to implement its growth plans could be adversely affected. The following information is a summary only of certain risk factors and is qualified in its entirety by reference to, and must be read in conjunction with, the detailed information appearing elsewhere in this MD&A.

Going Concern

The Company's capability to continue as a going concern is dependent upon its ability to obtain additional debt or equity financing to meet its obligations as they come due. If the Company were unable to continue as a going concern, then significant adjustments would be required to the carrying value of assets and liabilities, and to the balance sheet classifications currently used. While the Company has been successful in raising funds in the past, it is uncertain whether it will be able to raise necessary funds to further develop its products.

Risks Inherent in the Nature of the Health Clinic Industry

Changes in operating costs (including costs for maintenance, insurance), inability to obtain permits required to conduct the GLC's business, changes in health care laws and governmental regulations, and various other factors may significantly impact the ability of GLC to generate revenues. Certain significant expenditures,

including legal fees, borrowing costs, maintenance costs, insurance costs and related charges must be made to operate its clinics, regardless of whether the GLC is generating revenue.

Unfavourable Publicity or Consumer Perception

The success of the medical marijuana industry may be significantly influenced by the public's perception of marijuana's medicinal applications. Medical marijuana is a controversial topic, and there is no guarantee that future scientific research, publicity, regulations, medical opinion and public opinion relating to medical marijuana will be favourable. The medical marijuana industry is an early-stage business that is constantly evolving with no guarantee of viability. The market for medical marijuana is uncertain, and any adverse or negative publicity, scientific research, limiting regulations, medical opinion and public opinion relating to the consumption of medical marijuana may have a material adverse effect on our operational results, consumer base and financial results. Public opinion and support for medical and recreational cannabis use has traditionally been inconsistent and varies from jurisdiction to jurisdiction. While public opinion and support appears to be rising for legalizing medical and recreational cannabis, it remains a controversial issue subject to differing opinions surrounding the level of legalization (for example, medical marijuana as opposed to legalization in general).

Patient Acquisitions

The Company's success depends on its ability to attract and retain patients. There are many factors which could impact the Company's ability to attract and retain patients, including but not limited to the successful implementation of the Company's patient-acquisition plans and the continued growth in the aggregate number of patients selecting medical marijuana as a treatment option. The Company's failure to acquire and retain patients as clients would have a material adverse effect on the Company's business, operating results and financial condition.

Competition

The medicinal marijuana industry is intensely competitive, and GLC competes with other companies that may have greater financial resources and technical facilities. Numerous other businesses are expected to compete in the clinic space and provide additional patient servicing under the new regulatory regime in seeking patients that purchase medicinal marijuana. It is possible that LPs or other third parties could also establish their own medical clinics that are similar to the Company's, as there are no significant barriers to entry.

An increase in competition for cannabis and cannabinoid products may decrease prices and result in lower profits to the LPs. This increases the risk that LPs would not have funding available to provide LP grants.

Development Risks

Future development of the Company's business may not yield expected returns and may strain management resources. Development of the Company's revenue streams is subject to a number of risks, including construction delays, cost overruns, financing risks, cancellation of key service contracts, and changes in government regulations. Overall costs may significantly exceed the costs that were estimated when the project was originally undertaken, which could result in reduced returns, or even losses, from such investments.

Conflicts of Interest

Certain of the directors and officers of the Company may also serve as directors and officers of other companies involved in gold and precious metal or other natural resource exploration and development and

consequently the possibility of conflict exists. Any decisions made by such directors or officers involving the Company will be made in accordance with the duties and obligations of directors and officers to deal fairly and in good faith with the Company and such other companies. In addition, such directors declare their interest and refrain from voting on any matters in which such directors may have a conflict of interest.

Plans for Growth

The Company plans to grow rapidly and significantly expand its operations. This growth will place a significant strain on management systems and resources. The Company will not be able to implement our business strategy in a rapidly evolving market, without an effective planning and management process. To date, the Company has implemented some managerial, informational, operational and financial systems and controls, however, there can be assurance these systems and controls will be adequate. The Company may be required to manage multiple relationships with various strategic partners, users, advertisers and other third parties. These requirements will be strained in the event of rapid growth, or a large increase in the number of third-party relationships the Company has, as its systems, procedures or controls may not be adequate to support increased operations and management may be unable to manage growth effectively. To manage the planned growth, the Company will be required to significantly improve or replace existing managerial, informational, financial and operational systems, procedures and controls, and to expand, train and manage its intended growing base of personnel. The Company may also be required to expand its finance, administrative and operations staff. The Company may be unable to complete in a timely manner the improvements to its systems, procedures and controls necessary to support future operations, management may be unable to hire, train, retain, motivate and manage required personnel and management may be unable to successfully identify, manage and exploit existing and potential market opportunities.

Management's Responsibility for Financial Statements

The information provided in this report is the responsibility of management. In the preparation of these statements, estimates are sometimes necessary to make a determination of future values for certain assets or liabilities. Management believes such estimates have been based on careful judgments and have been properly reflected in the unaudited condensed consolidated interim financial statements.
