Following the Transaction, Mr. Steinepreis' Common Share ownership in the Issuer decreased to approximately 15.44%, since the effective date of Mr. Steinepreis' last Early Warning Report (January 17, 2022) and after taking into account subsequent issuances of Common Shares by the Issuer since said last report.
