Private Placements
FINDER FEE AGREEMENT

This letter agreement (this "**Finder Fee Agreement**") sets forth the understanding between PACIFIC ASIA CAPITAL PTE. LTD. (the "**Finder**") and the Company as to the terms of the commission payable to the Finder for introducing investors to the Company with respect to various proposed private placements (the "**Private Placements**") of either units or common shares of the Company (collectively, the "**Securities**").

The Finder is under no obligation to introduce to the Company investors who wish to subscribe to the Private Placements. Nothing in this Finder Fee Agreement shall be construed as constituting the Finder as an agent of the Company.

The Company shall pay the Finder a cash commission (the "**Commission**") equivalent to Twenty Percent (20%) of the gross proceeds from subscribers to the Private Placements who are introduced to the Company by the Finder. The Company shall pay the Commission due to the Finder within five business days of the closing of each of the Private Placements.

The Company shall obtain regulatory approval for the issuance of the Securities and payment of the Commission to the Finder, and the Company shall be responsible for payment of any related filing fees and legal fees. The Company will take all steps necessary to properly issue the Securities to the subscribers introduced by the Finder, including endorsing the certificates representing the Securities with appropriate legends in the jurisdictions relevant to the private placement. The Company proposes to issue the Securities subject to a hold period of six months and one day.

The term of this Finder Fee Agreement is for 2 years commencing July 1, 2015 and terminating on July 1, 2017 unless earlier terminated by either party on giving 2 month's written notice of termination to the other.
